

## **SS-1: Common Core Standards and IB MYP Implementation Monitoring Sacks & Felton**

**District 97 Board Goal #1 for 2014-15**—Establish Plan to Monitor Full and Effective Implementation of Common Core State Standards and International Baccalaureate Middle Years Program

### **What does success look like?**

A calendar of regular reporting to the Board regarding the progress toward full implementation of Common Core and IB will be established. Once full implementation is achieved, a new calendar will be created for regular monitoring and oversight of Common Core and IB. These calendars will include reporting dates, board presentation dates, and a framework for the reports.

### **Process to Date**

Amy and Denise developed an agenda for meeting with the administration concerning this topic. They then met with Al, Helen, and Carrie twice to discuss the development of a calendar and the possible content of reports and presentations to the board. The draft calendar was presented to the board at its November 4<sup>th</sup> meeting. Board members were asked to submit questions concerning IB and Common Core implementation to the administration by November 14<sup>th</sup>. The administration is using these questions as well as the topics listed below to develop its reports.

### **Proposed Calendar of Reporting for 2014-2015**

The information concerning Common Core Standards and International Baccalaureate implementation will be divided into two reports based on grade levels.
