

#### <u>NEW for 2017</u>

- Eliminate STAAR A and STAAR L as separate versions
- All STAAR assessments in two formats paper or enhanced online version
- Changes in Vocabulary Performance Categories and Progress Categories
- Changes in eligibility for Accommodations
- 3 Passing Rates / 4 Performance Levels (new language)
- 1. HB 743 passed in 2015
  - Requires STAAR to be designed so that:
    - Grades 3-5, 85% complete in two hours; Grades 6-8, 85% complete in three hours
    - Tests were shortened proportionally and maintain validity and reliability
    - Removal of Short Answer Reading questions from English I and English II

# Accountability has 4 Tiers

- 1 Ratings based on 4 Performance Indexes
- 2 Distinction Designations
- 3 System Safeguards
- 4 Community and Student Engagement / Compliance

# <u>Indexes</u>

- Index 1: Student Achievement
- Index 2: Student Progress
- Index 3: Closing Performance Gap
- Index 4: Postsecondary Readiness

# **Distinction Designations**

- 7 possible Distinction Designations for campuses that earn "Met Standard"
  - Top Quartile Student Progress (Index 2 score)
  - Top Quartile Closing Achievement Gaps (Index 3 score)
  - Academic Achievement: Reading/ELA
  - Academic Achievement: Math
  - Academic Achievement: Science
  - Academic Achievement: Social Studies
  - Postsecondary Readiness
  - 1 possible Distinction Designation for Districts that earn "Met Standard"
    - Postsecondary Readiness

# **Distinction Designations**

- Each campus is evaluated compared to its Campus Comparison Group
- Campus Comparison Group
  - Each campus is first identified by campus type (elementary, middle, elementary/secondary, high school)
  - Campus Comparison Group is the 40 campuses that are "most similar" (determined by linear distance) based on 7 variables
    - 1. Grade Span
    - 2. Total Student Enrollment
    - 3. Percentage of Economically Disadvantaged
    - 4. Percentage of English Language Learners (ELLs)
    - 5. Mobility Rate (percentage of students enrolled at the campus for less than 83% of the school year)
    - 6. Percentage served by Special Education
    - > 7. Percentage enrolled in an Early College High School Program
    - Each campus has a unique Campus Comparison Group

# System Safeguards

- Components
  - Performance Rates
    - State and Federal targets
  - Participation Rates
  - Graduation Rates
- System Safeguards are included to ensure that
  - Poor performance by one student group in one area/subject is not masked by the overall index scores earned by a campus or District
  - All state and federal accountability requirements are covered

### Moving Forward

Overview of 2018 Accountability HB22

- A, B, C, D, or F in <u>each</u> Domain
- Must be mathematically possible for all districts and campuses to earn an A

Domains

- 1. Student Achievement
- 2. School Progress
- 3. Closing the Gaps

Community and Student Engagement eliminated from State Accountability

- August 2018 Campuses will be rated Met Standard or Improvement Required (they will not receive A-F letter grade)
  - January 1, 2019 TEA releases report showing the ratings that each campus would have received in 2017-18 if the indicators were in place for 2017-18

- August December 2017
  - Stakeholder feedback
  - State meetings
- January April 2018
  - Continue stakeholder feedback
  - Commissioner final 2018 A-F decision
- May June 2018
  - 2018 A-F Accountability manual created
  - Public comment on manual
  - 2018 A-F manual adoption
