- SUBJECT: USDA Rural Development Housing Preservation Grant (HPG)
- MESSAGE: The Alpena County Home Improvement Program would like to apply to USDA Rural Development for the 2024 Housing Preservation Grant (HPG) in the amount of \$150,000. The matching funds for this grant are CDBG/Program Income in the amount of \$75,000, and there is no County match.

The Alpena County Home Improvement Program has applied for and been awarded many Housing Preservation Grants in the past which is a key source of funding for this Program. The most recent grant awarded was in 2023 for \$147,760 which is still being administered, and has assisted six homeowners so far, with at least an additional four anticipated by October 2024. The prior Grant from 2022 in the amount of \$137,220 assisted a total of 14 low income homeowners with home repair needs.

I am seeking Board approval to apply for said grant, and would further ask that the Chairman of the Board be authorized to sign the pre-application and future documents relating to this HPG application.

The pre-application deadline is July 29, 2024.
