Presentations/ Recognitions

Denton ISD had six seniors, who have been honored for their high scores on the Preliminary Scholastic Aptitude Test (PSAT), an assessment taken last year by high school juniors nationwide. They were among the 1.2 million students from 20,000 high schools who entered the 2009 Merit Program.

Two seniors Daniel Pickett & Sophia Tanner have been named National Merit Semifinalists. They are among an elite group of only 1,600 semifinalists throughout the United States who were named in the 2008 National Merit Scholarship Program. These national semifinalists are now eligible to compete for 8,000 Merit Scholarship Awards, which totals more than \$30 million in scholarships.

Denton ISD had three commended scholars, Gina Bishop, David Heyen, Teodoro Soares from Guyer High and Mary Strange from Ryan High. To be named a commended scholar, the students had to place in the top five percent nationwide on the PSAT test. Teodoro Soares was also was named a National Hispanic Recognition Program Scholar Finalist.

The College Board recently announced that 98 Denton ISD students were recognized for their exceptional achievement on Advanced

Placement courses and exams. The College Board recognizes high school students, who have distinguished themselves academically, by announcing AP Scholar award recipients.

Artwork from six Denton Independent School District students was recently showcased by the Texas Art Education Association at the Texas Association of School Boards exhibit in Dallas. The exhibit showcased kindergarten through 12th-grade art from across Texas.

Report from Investment Pools

The Board of Trustees received information as to the impact of the changes in the current financial market on the district's investments in the various investment pools. The District currently invests in the following investment pools:

TexPool – a government pool investing primarily in a portfolio of short-term U. S. Treasury and government agency securities, including repurchase agreements collateralized by U. S. Treasury and government agency securities. TexPool does not invest in any corporate securities or commercial paper.

TexSTAR – a local government investment pool created under the Interlocal Cooperation Act specifically tailored to meet Texas state and local government investment objectives of preservation of principal, daily liquidity and competitive yield. TexSTAR does not invest in derivatives, which include instruments which have embedded features that alter their character or income stream or allow holders to hedge or speculate on a market or spreads between markets that are external to the issuer or are not correlated on a one-on-one basis to the associated index or market, commercial paper or certificates of deposit.

First Public – Lone Star Investment Pool – Liquidity Plus Fund – designed with the objectives of safety of principal, daily liquidity, and the highest possible rate of return. It invests only in securities issued or backed by the U. S. Government or its agencies and instrumentalities.
