**Public Hearing** for TAPR Report Members of the division of curriculum, instruction and staff development conducted a Public Hearing on the Texas Academic Performance Report (TAPR), which replaced the AEIS report. Dr. Mike Mattingly, assistant superintendent, and Lyneille Meza, coordinator of data and assessment gave an overview of student performance for Denton ISD.

- In student performance of the STAAR accountability assessments, the percentage of students who passed at Phase In 1/ Level II or above included: Reading – 85 percent in district passed compared to 80 percent at the state; Math -83 percent in district passed compared to 79 percent at the state; Writing – 68 percent in district passed compared to 63 percent in state; Science – 84 percent in district passed compared to 82 percent in state, and Social Studies – 79 percent in district passed compared to 76 percent in state.
- In teacher experience, the report stated that 15 percent of Denton ISD teachers had more than 20 years of experience and 27 percent had one to five years of experience.

Board President Charles Stafford asked what percentage of teachers

was highly qualified and Dr. Mattingly said 100 percent. Marcia Kellum, coordinator of reading recovery, presented the Early Literacy Inventory (ELI) and the Spanish Early Literacy Inventory (SELI) reports. In ELI, the report highlighted that 95 percent of the kindergarten students, 91 percent of the first-graders and 90 percent of second-graders were Stage 2-3 (Progressing/On-level) by the end of the 2012-13 school year. The outcomes also show significant growth in all the literacy measures.

In SELI, 87 percent of the bilingual kindergarten students, 91 percent of the first-graders and 89 percent of the second-graders were Stage 2-3 (Progressing/On Level) by the end of the 2012-13 school year. These results also show significant growth in all the literacy components.
