EHC Industries is the apparent low bidder for this project, with a total Base Bid of \$223,800.00 including the \$20,000.00 allowance for the removal of asbestos containing materials identified in the scope of work. EHC also had a low bid of \$16,000.00 for the Alternate Add #1 identified in the project specifications. Safe Environment was the second low bidder for the Base Bid work at \$232,800.00. Safe's Alternate Add #1 cost was \$26,840.00.
