January 2021	Student projections per campus established. Review enrollments/boundaries. Prepare Campus/Dept. Budget Training manuals.

January 19, 2021	Board budget workshop-Board Initiatives, projected enrollments, and budget issues.

August 2021	Public hearings on proposed 2021-2022 tax rate and proposed budget. A quorum must be present for public hearing. Final 2021-2022 budget approved and 2021-2022 tax rate approved at the regularly scheduled Board of Trustees meeting. Certified property values approved at regularly scheduled Board of Trustees meeting.		
September 1, 2021	Approved 2021-2022 operating budget for General Operating, Food Service, and Debt Service funds implemented.
