BE IT RESOLVED, that any one of the following individuals: Regan Brandon
be and he or she is hereby authorized on behalf of this Corporation, to negotiate credit accommodations and/or make a loan or loans to incur any amount of indebtedness, in addition to any outstanding indebtedness, from Capital One, National Association (the "Lender"), said indebtedness to be represented by a note or notes or other evidences of indebtedness made and executed by this Corporation from time to time, for the amount or amounts to be extended by Lender to this Corporation on forms drafted by the Lender for such amounts, and with such maturities, and with such interest, and on such other terms, conditions, and provisions as the above designated officer(s) of this Corporation may deem necessary, advisable, and/or prope in his or her sole and uncontrolled discretion, and to sign, execute and endorse such other documents as may be necessary or required by the Lender to evidence or secure such indebtedness, including but not limited to any and all agreements, obligations, pledges, and/or other instruments necessary or required by the said Lender for its protection in its dealings with this Corporation.
BE IT FURTHER RESOLVED, that in order to secure all indebtedness of every kind, nature and character, whether now existing or hereafter arising, of this Corporation to the Lender, the above designated individual(s) be and he or she is hereby authorized, empowered and directed to act on behalf of this Corporation to mortgage, pledge, hypothecate or otherwise encumber any property now or hereafter belonging to the Corporation, as security for the payment of any loans, obligations or any indebtedness that this Corporation owes to the Lender. The above designated individual(s) have the right to mortgage, pledge, hypothecate or encumber all property, including, but not limited to all immovable (real) property and all personal (movable) property. The right to mortgage, pledge, hypothecate or encumber property of the Corporation may be exercised when any loan is initially obtained, or at any other time or times, and may be in addition to or in substitution of any other property previously mortgaged, pledged, hypothecated or encumbered to the Lender.
BE IT FURTHER RESOLVED, that the above designated individual(s) be and he or she is hereby authorized to execute and deliver one or more mortgages, collateral mortgages, security agreements or pledge agreements in favor of the Lender. Any mortgages, collateral mortgages, security agreements or pledge agreements may contain such terms, conditions and provisions as he or she may deem necessary, advisable, and/or proper in his or her uncontrolled discretion, confessions of judgment, waivers of appraisal, waiver of the right to a jury trial, and waiver of any other rights and notices, all of which waivers are specifically consented to by this Board of Directors.
BE IT FURTHER RESOLVED, that these resolutions are hereby ratified and approved, and will remain in full force and effect, and Lender is entitled to rely upon such resolutions, until Lender receives actual written notice of their revocation.

#### Rebate Addendum

The following represents an Addendum to the Capital One Bank Treasury Management Commercial Card Agreement dated 12-13-12 between Capital One, N.A.("Bank") and MINEOLA ISD ("Company") (the "Agreement").

Terms not defined herein shall have the same meaning ascribed to them in the Agreement.

Company wishes to participate in the Rebate Program, subject to the following guidelines:

Bank shall pay to Company, within 60 days of each Anniversary Date, revenue share based on Company's total net purchase volume, less credits, charge-backs, credit losses, cash advances, delinquency assessments, fees and unauthorized charges ("Rebates"). Rebates will be paid in accordance with the table below:

Payments received after the Payment Due Date do not qualify for Rebate.

Table references basis points on spend volume - one basis point = one hundredth of a percentage point (or .01%).

\*Large ticket = transactions greater than \$7,500 carrying Level III data appended to transaction record.

#### Additional Terms and Conditions

- A. Eligibility is restricted to accounts in good standing.
- B. Suspension, fraud or abuse will result in forfeiture of any Rebates earned after the then-preceding Anniversary Date.
- C. This Rebate Program is void where prohibited by federal, state or local law.
- D. Company is responsible for any fees, taxes and charges for Rebates paid.
- E. Bank reserves the right to alter, substitute or terminate the entire Rebate Program for any reason at any time without notice.
- F. There is no limit to the amount of Rebates a company can earn.
- G. Termination of the Agreement, for any reason, will result in forfeiture of any Rebates earned after the then-preceding Anniversary Date.

All other terms and conditions, as outlined in the Agreement, shall remain in full force and effect.
