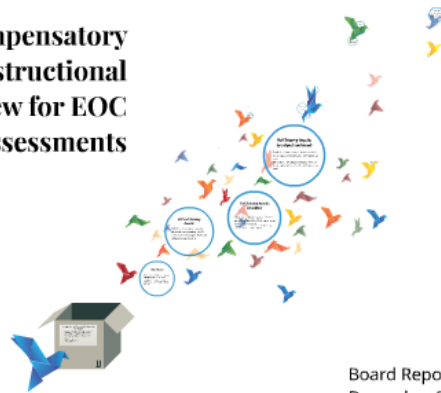
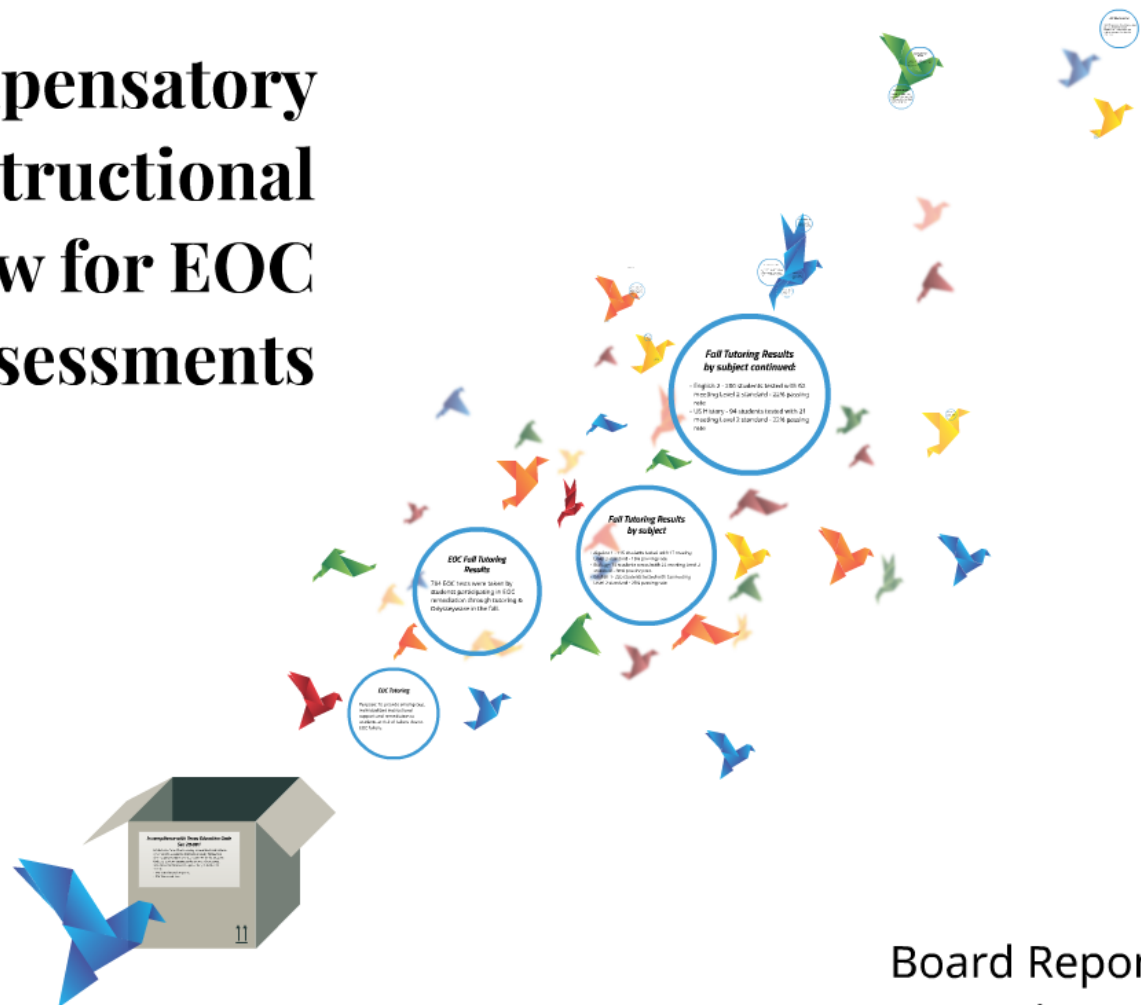

2015-16 Compensatory Accelerated Instructional Program Review for EOC Assessments

In compliance with Texas Education Code Sec 29.081

ECISD has offered the following accelerated instructional programs to accelerate instruction under Subsection (b-1) requirements in any subject in which the student failed to perform satisfactorily on an end-of-course assessment instrument required for graduation as noted:

- EOC Tutoring Fall & Spring
- EOC Extended Year

EOC Tutoring

Purpose: To provide small group, individualized instructional support and remediation to students at risk of failure due to EOC failure.



EOC Fall Tutoring Results

784 EOC tests were taken by students participating in EOC remediation through tutoring & Odysseyware in the fall.



Fall Tutoring Results by subject

- Algebra 1 - 116 students tested with 17 meeting Level 2 standard - 15% passing rate
- Biology- 74 students tested with 22 meeting Level 2 standard - 30% passing rate
- English 1- 220 students tested with 56 meeting Level 2 standard - 25% passing rate



Fall Tutoring Results by subject continued:

- English 2 - 280 students tested with 62 meeting Level 2 standard - 22% passing rate
- US History - 94 students tested with 21 meeting Level 2 standard - 22% passing rate

Fall Results All Tests

ALL TESTS TAKEN - 784
tests were taken with 178
meeting Level 2 standard
- 23% passing rate

Tutoring Results - Fall EOC

The most positive gains noted were:

- Biology with 30% passing rate
- English 1 with 25% passing rate

EOC Tutoring Spring

863 EOC tests were taken by students participating in Spring EOC remediation through tutoring & Odysseyware at our high school campuses.

Tutoring Results Spring EOC

- Algebra 1 - 196 students tested with 68 meeting Level 2 standard - 35% passing rate
- Biology - 79 students tested with 46 meeting Level 2 standard - 58% passing rate
- English 1- 224 students tested with 46 meeting Level 2 standard - 21% passing rate

Spring Tutoring Results continued:

- English 2 - 344 students tested with 106 meeting Level 2 standard - 31% passing rate
- US History - 364 students tested with 285 meeting Level 2 standard - 78% passing rate

Spring EOC Tutoring All Tests

- 863 EOC tests were taken with 445 meeting Level 2 standard - 52% passing rate

Tutoring Results Spring EOC

The most positive gains noted were:

- US History with a 78% passing rate
- Biology with a 58% passing rate

EOC Extended Year

Purpose: To provide small group, individualized instructional support and remediation to students at risk of future EOC failure.

EOC Extended Year

- 265 EOC tests were taken by students participating in EOC remediation through extended year services at our high school campuses.

EOC Extended Year by Content Area

- Algebra 1 - 55 students tested with 11 meeting Level 2 standard - 20% passing rate
- Biology - 15 students tested with 5 meeting Level 2 standard - 33% passing rate
- English 1- 69 students tested with 12 meeting Level 2 standard - 17% passing rate

Extended Year Results continued:

- English 2 - 88 students tested with 17 meeting Level 2 standard - 19% passing rate
- US History- 38 students tested with 18 meeting Level 2 standard - 47% passing rate

***EOC Extended Year
All Tests***

265 EOC tests were taken with 63 meeting Level 2 standard - 24% passing rate.

EOC Extended Year Program

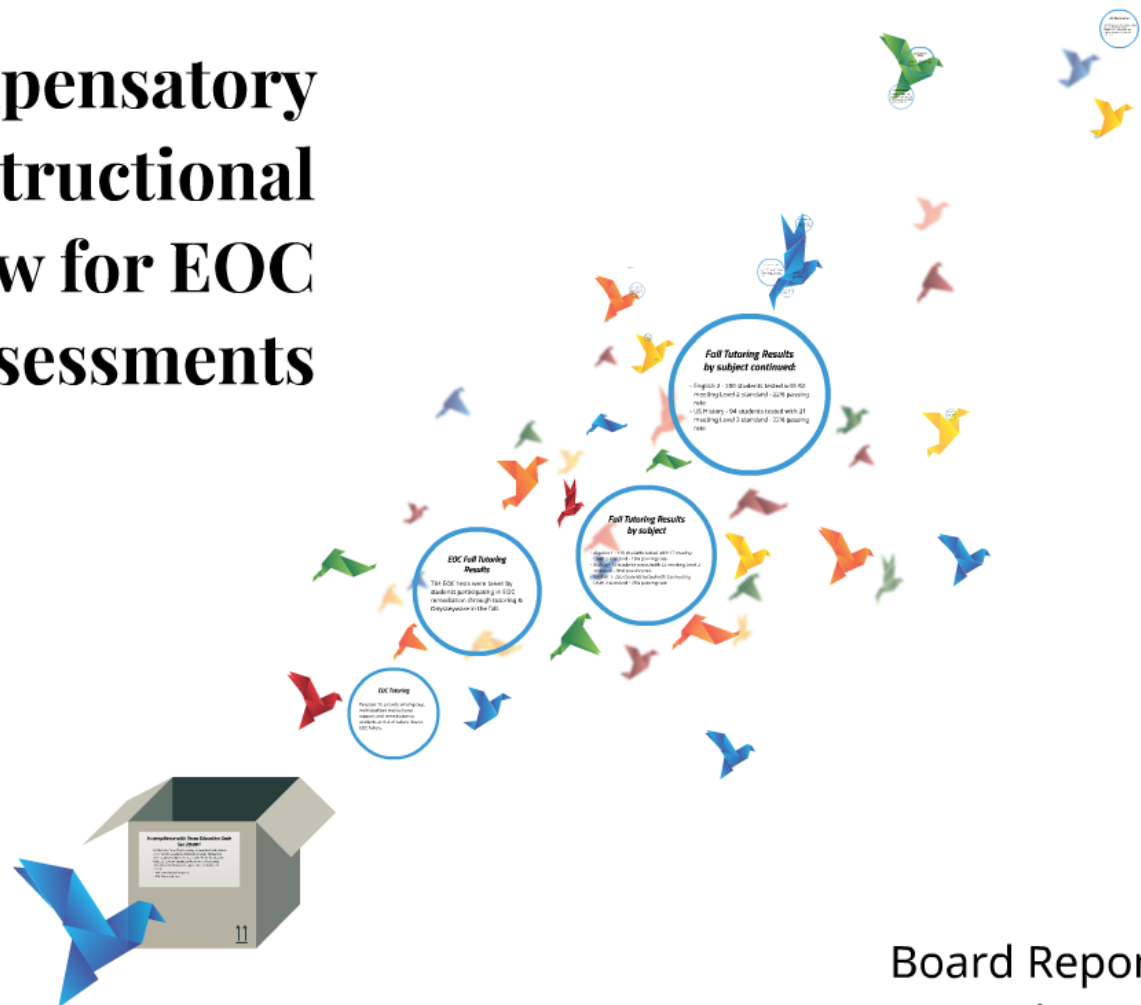
The most positive gains following the third administration were:

- US History with a 47% passing rate
- Biology with a 33% passing rate

Overall Summary

The most successful remediation was between the Fall and Spring testing administration with an overall passing rate at **58%** - this supports the need for continued early intervention.
