Senate Passes Controversial Anti-Bullying Bill

On Wednesday the Senate passes Senate Bill 137 introduced by Sen. Rick Jones. The bill would mandate school district to develop a bullying policy. If the bill is passed, districts would have 60 days to adopt and implement a policy preventing bullying and harassment.

The bill would also require the board to hold a public hearing on the policy and to submit it to the MDE.

"Bullying or harassment" is defined as abuse of a pupil by one or more other pupils that substantially interferes with educational opportunities, benefits, or programs of one or more pupils, or adversely affects the ability of a pupil to participate in or benefit from educational programs or activities by placing him or her in reasonable fear of physical harm or by causing emotional distress.

"At school" would mean in a classroom, elsewhere on school premises, on a school bus or other school-related vehicle, or at a school-sponsored activity or event whether or not it is held on school premises. The term would include conduct using a telecommunications access device or telecommunications service provider that occurs off school premises if the device

or provider is owned by or under the control of the school district or PSA.

Before the bill passes, the Republicans offered and substitute that added the following language:

This section does not prohibit a statement of a sincerely held religious believe or moral conviction of a school employee, school volunteer, pupil or a pupil's parent or guardian.

Democrats argued that this exception would essential allow for a "license to bully" and Supt. Mike Flanagan issued a statement calling the bill "a joke."
