SUBJECT: Purchases of Over \$10K - Memo No: SB23-180

**Curricular Materials Refresh** (Informational Item)

#### **NSBSD Policy Manual:**

**BP 3300** Expenditures/Expending Authority: The Superintendent or designee may purchase supplies, materials, and equipment in accordance with the law. The Superintendent or designee shall not authorize any proposed expenditure that exceeds the major budget classification allowance against which the expenditure is the proper charge unless an amount sufficient to cover the purchase is available in the budget for transfer.

**BP 3310**, Purchasing Procedures: The School Board desires to ensure that maximum value is received for money spent by the district and that records are kept in accordance with the law. The Superintendent or designee may issue and sign purchase orders.

**BP 3311**, Bids: All purchases in the amount of \$20,000 or more shall be based, when possible, on three competitive bids. The Superintendent or designee shall establish procedures to ensure that formal advertised bids are solicited for purchases over \$50,000. When competitive sources do not exist to allow for a bid process, Business office procedures provide for sole source purchases.

#### **Issue Summary:**

The textbook purchases are outlined below. All purchases support previously adopted materials and are meant to refresh existing supplies:

**Northwest Text Book Depository** is a competitively priced vendor where we purchase the bulk of our teacher and student text book editions. They offer reliable and affordable shipping. Please see attached quotes which are broken down by school site.

**The Math Learning Center** is the vendor for Bridges in Mathematics, our adopted curricular resource in grades K-2 and Number Corner which is used in grades K-5. In addition to the parts and pieces required by many of our sites, we are purchasing an entire set to be used for moedling and recording lessons by C&I staff.

**Houghton Mifflin Harcourt** is the publisher of both our adopted MS Social Studies texts, as well as our MS/ HS Science texts. Our initial contract with the company for online access to texts expired this year, and so this is reflective of a 1 year extension to our existing licenses.
