Dear Mr. Revell:


Please place on the agenda of the next board meeting of the Board of Trustees of ECISD a request to sell 1308 Muskingum Ave for \$13,000.00, which is less than the market value specified in the judgment of foreclosure against the property and is also less than the total amount of the judgment against the property.

Pursuant to the inter-local agreement, which was set up to sell these properties, Trower Realtors has obtained a contract on the property and the buyer, George Beseril, has deposited \$500.00 with Atkins Peacock & Linebarger Goggan, LLP.
