These are suggested updates from MSBA due to the conclusion of the legislative session. Policy 413 has substantial changes which make reporting procedures consistent with other policies. Policy 419 prohibits the use of electronic cigarettes and expands the definition of tobacco. Policy 526 clarifies that "hazing" under the policy is connected to a school-related purpose.

Discussion – Will get clarification regarding the following: 419 - can a student be allowed to possess a cessation product?
413 Harassment Policy – if something is offensive to a student could

mean many various things and how would this be addressed if it is on a student's clothing for example.
