WHEREAS, Vienna Township has previously designated and received Community Development Block Grant Funds; and

WHEREAS, Vienna Township has designated \$20,000.00 2022-2024 Community Development Block Grant Funds grant to 2024 ADA complaint Doors and Opener Project; and

WHEREAS, the 2024 ADA complaint Doors and Opener bid was advertised and emailed to potential bidders, including women owned businesses and minority owned businesses; and

WHEREAS, the 2024 ADA complaint Doors and Opener bid was due July 22, 2025; and

WHEREAS, 2024 ADA complaint Doors and Opener bid received no bids by the due date; and

WHEREAS, Vienna Township received directions from the Planning Commission that we could solicit quotes for 2024 ADA complaint Doors and Opener project; and

WHEREAS, Vienna Township received three quotes and chose the lowest, responsive, responsible bidder, which is Flylock Security Solutions at 2685 Lapeer Rd., Auburn Hills, MI 48326; and

WHEREAS, Vienna Township, Genesee County Planning Commission, and Flylock Solutions had a preconstruction meeting on Wednesday, August 13, 2025; and

WHEREAS, Flylock Solutions said it could take up to six to eight weeks to receive the supplies ordered; and

WHEREAS, Vienna Township has a timeline of September 30, 2025, to spend 2024 Community Development Block Grant Funds; and

NOW, THEREFORE, BE IT RESOLVED, that the Vienna Township Board hereby requests the \$20,0000.00 in Community Development Funds timeline be extended from September 30, 2025, to December 31, 2025.
