Meeting was called to order at 9:35AM. The meeting included call to order, Principal's remarks, previous business, new business, building use requests, and adjournment.

A March 6<sup>th</sup> joint CEC meeting was held at Scholls Heights Elementary with CEC members from neighboring schools.

**Public Input:**

Mrs. Sinapi is a third grade teacher at Hiteon who is working on her administrator's license. She sat in on the meeting to learn more about the roles and responsibilities of the Community Engagement Committee.

**Principal's Remarks:**

- Ongoing discussion about the community budget teaching sessions that will be taking place at all of the schools in the district before spring break and the potential impact at Hiteon of the budget reductions.
- There was a good turnout at Kindergarten Roundup on March 8<sup>th</sup> but the numbers are still fluctuating. We are still under the number of full day kindergartener's needed for a 2<sup>nd</sup> full day class.
- Talked about the joint CEC meeting that was held at Scholls Heights. At the meeting we discussed engaging local businesses by using a PBIS type of form they could have on hand to give to students they observe using safe/responsible/respectable behavior. Draft versions of the PBIS form, as well as a letter of introduction were reviewed and some modifications were requested. The plan is to finalize the documents and have each school choose one business to approach about piloting the project to see how it will work sometime before the end of the school year

**Previous Business:**
