Consider Approval of Renewal of Contract 2023.602 Athletic, Trainer and Physical Education Equipment, Supplies, Clothing, and Services

**Background:**

In June 2024, the Board approved the renewal of Contract 2023.602 Athletic, Trainer and Physical Education Equipment, Supplies, Clothing, and Services in the amount of \$2,000,000. To date, \$1,620,142 of the approved estimated contract value has been encumbered. The scope of this contract is to provide a purchasing method with qualified suppliers for athletic equipment, supplies, and related services. This includes the purchases of clothing/uniforms and other related physical education (P.E.) supplies and equipment for all age-appropriate grade levels throughout the District on an as-needed basis. It is the recommendation of the Director of Purchasing to approve the renewal of this contract for an estimated annual contract value of \$2,000,000. This is the final renewal option remaining on this contract.
