

**REGULAR EDUCATION TRANSPORTATION
SERVICES CONTRACT**

THIS AMENDMENT entered as of the 9th day of May 2023 is made by and Between the Board of Education of Oak Park Elementary School District 97, Cook County, Illinois. (“District”) and Lakeview Bus Lines, Inc., (“Contractor”) (collectively referred herein as “the Parties”).

WITNESSETH

WHEREAS, the parties entered into that certain Transportation Services Contract, effective July 1, 2020, (“Agreement”), for Regular Education school year and extended school year student Transportation services; and

WHEREAS the Parties desire to further extend the term of the Agreement.

NOW, THEREFORE, for good and valuable consideration the receipt of which is Acknowledged by the Parties, it is mutually agreed to as follows:

1. **TERM.** The term of the Agreement is hereby extended for two (2) additional years commencing July 30, 2023, and continuing through July 30, 2025.
2. **Compensation.** The rates for the services provided hereunder shall increase in the amount of 7.5% for the 2023-2024 contract year and 6% increase for the second year of contract 2024-2025.
3. **Conflict of Terms.** Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect. To the extent any of the terms and conditions of the original Agreement conflict with the terms and conditions of this Amendment, the terms and conditions contained herein shall control.
4. COVID Cleaning charges will be removed at the discretion of the District and can be discontinued at any time with a letter stating as such.
5. The Contractor will ensure the school bus driver is the last person leaving every school bus and no passenger is left behind or remains on the vehicle at the end of a route, a work shift, or the workday.

6. The Contractor will test the cellular radio telecommunications device or two-way radio to ensure that it is functioning properly before the bus is operated, and before leaving the bus at the end of each route, work shift, or workday, to walk to the rear of the bus.

7. The Contractor may charge a fuel escalator cost of \$16.25 per bus for am and pm routes, field trips, and charters should the price of fuel gas and diesel gas rise to \$4.00/gallon and the District has exercised the option to remove COVID Cleaning charges noted in Section 4 of this contract. However, if the price of fuel gas and diesel goes below \$4.00, the fuel escalator will be eliminated 1 month after fuel prices change. The District cannot be charged for both COVID cleaning fees and a fuel escalator charge. All other situations may be negotiated between the Parties in the spirit of cooperation.

SPECIAL EDUCATION (IN-DISTRICT) TRANSPORTATION SERVICES CONTRACT

THIS AMENDMENT entered as of the 9th day of May 2023 is made by and Between the Board of Education of Oak Park Elementary School District 97, Cook County, Illinois. (“District”) and Lakeview Bus Lines, Inc., (“Contractor”) (collectively referred herein as “the Parties”).

WITNESSETH

WHEREAS, the parties entered into that certain Transportation Services Contract, effective July 1, 2020, (“Agreement”), for In-District Special Education school year and extended school year student Transportation services; and

WHEREAS the Parties desire to further extend the term of the Agreement.

NOW, THEREFORE, for good and valuable consideration the receipt of which is Acknowledged by the Parties, it is mutually agreed to as follows:

1. **TERM.** The term of the Agreement is hereby extended for two (2) additional years commencing July 30, 2023, and continuing through July 30, 2025.
2. **Compensation.** The rates for the services provided hereunder shall increase in the amount of 7.5% for the 2023-2024 contract year and 6% increase for the second year of contract 2024-2025.
3. **Conflict of Terms.** Except as amended herein, all other terms and conditions of the Agreement shall remain in full force and effect. To the extent any of the terms and conditions of the original Agreement conflict with the terms and conditions of this Amendment, the terms and conditions contained herein shall control.
4. COVID Cleaning charges will be removed at the discretion of the District and can be discontinued at any time with a letter stating as such.
5. The Contractor will ensure the school bus driver is the last person leaving every school bus and no passenger is left behind or remains on the vehicle at the end of a route, a work shift, or the workday.

6. The Contractor will test the cellular radio telecommunications device or two-way radio to ensure that it is functioning properly before the bus is operated, and before leaving the bus at the end of each route, work shift, or workday, to walk to the rear of the bus.

7. The Contractor may charge a fuel escalator cost of \$16.25 per bus for am and pm routes, field trips, and charters should the price of fuel gas and diesel gas rise to \$4.00/gallon and the District has exercised the option to remove COVID Cleaning charges noted in Section 4 of this contract. However, if the price of fuel gas and diesel goes below \$4.00, the fuel escalator will be eliminated 1 month after fuel prices change. The District cannot be charged for both COVID cleaning fees and a fuel escalator charge. All other situations may be negotiated between the Parties in the spirit of cooperation.
