March 24, 2015

The Collin County Community College District ("Collin College," "Collin" or "District") conducted its regular monthly Board of Trustees meeting on March 24, 2015, in the Board Room, Room 139, Collin Higher Education Center, with Chairman Mac Hendricks presiding. Trustees in attendance were Dr. J. Robert Collins, Mr. Steve Cone, Mr. Andy Hardin, Ms. Jenny McCall, Mr. Adrian Rodriguez, Mr. Larry Wainwright, and Ms. Nancy Wurzman. Trustee Stacy Anne Arias was absent. Other attendees included incoming District President Neil Matkin and Mrs. Matkin, Interim District President Colleen Smith, Collin College administrators, faculty, students, staff, community members, and media and vendor representatives.

CALL TO ORDER

Chairman Hendricks called the March 24, 2015, meeting of the Board of Trustees of Collin County Community College District to order at 5:34 p.m. The Board met at the Collin Higher Education Center, 3452 Spur 399, McKinney, Texas 75069.

ADJOURNMENT TO CLOSED OR EXECUTIVE SESSION

Chairman Hendricks recessed the meeting to closed session at 5:35 p.m. in Room 135, Board Conference Room, as authorized by Article 551.001, Texas Government Code, Sections 551.071 Consultations with Attorney – to consult with the District's attorney, in person or by phone, to seek the advice regarding pending or contemplated litigation, a settlement offer, or on a matter in which the duty of the attorney to the District under the Texas Disciplinary Rules of Professional Conduct of the State Bar of Texas clearly conflicts with Chapter 551 of the Texas Government Code; Section 551.074: Personnel – to deliberate the appointment, employment, evaluation, reassignment, duties, discipline, or dismissal of a public officer or employee: 1) Deliberation regarding the contract for employment of Dr. H. Neil Matkin as Collin College District President and 2) Consultation with the board attorney regarding the contract for employment of Dr. H. Neil Matkin as Collin College District President; and Section 551.072 Deliberations about Real Property.

OPEN SESSION

Chairman Hendricks reconvened the meeting at 7:00 p.m. in Room 139 and welcomed those in attendance. Chairman Hendricks called on Shirley Harmon, Executive Assistant to the District President/Secretary to the Board of Trustees, to certify posting of the notice of the meeting.

CERTIFICATION OF THE NOTICE OF THE MARCH 24, 2015, MEETING OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES

Ms. Shirley Harmon certified the notice of the March 24, 2015, Collin County Community College District Board of Trustees meeting was posted according to Article 551.001 of the Texas Government Code.

PLEDGES OF ALLEGIANCE

Chairman Hendricks led the pledges of allegiance to the American and Texas flags.

APPROVAL OF THE MINUTES OF THE MARCH 6, 2015, REGULAR MEETING OF THE COLLIN COUNTY COMMUNITY COLLEGE DISTRICT BOARD OF TRUSTEES

On motion of Mr. Wainwright, seconded by Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved the minutes of its March 6, 2015, regular meeting. The meeting was originally scheduled for February 24, 2015, but due to inclement weather had to be rescheduled to February 27 and March 5 and finally took place on March 6, 2015.

PUBLIC COMMENTS

No public comments were presented.

WELCOME

Chairman Hendricks welcomed visitors from Leadership McKinney 2015 class and students from Collin's leadership classes of Professors Debra St. John and Judi Wohead.

PRESENTATION

1. Construction Update: Mr. Kyle Ehle of Pogue Construction Company, presented a construction update on the health sciences center and new conference center at the Central Park Campus. He showed a slide of the construction area and noted that Parking Lot A had been completed and was currently in use. Interior work is underway in the conference center and the structural steel and framing are almost complete on the health sciences building; the green board will be installed as the next step. In answer to Mr. Wainwright's question, Mr. Ehle said that construction is on schedule and that the conference center will be completed in August 2015 and the health sciences building in May 2016.

2. Vice President of Public Relations and College Development Lisa Vasquez presented the new marketing plan *Campaign 2015* to the Board of Trustees. She said the concepts for the campaign began with students and alumni. Saying the college had come a long way in 30 years, Ms. Vasquez said that brand acceptance had doubled since 1999 and that name recognition of "Collin College" was 93%, while recognition of "CCCC" was 96%. Sixty-nine percent of those surveyed agreed Collin offered quality academics, which is the case for many community colleges. Collin ranks high among its peers in the ranking for quality academics.

Ms. Vasquez said the goal of *Campaign 2015* is to develop a sense of pride in Collin College and improve acceptance of its academic quality. The targeted audience will be prospective students age 13-24, and the secondary target will be parents, people who affect the decisions of students, nontraditional students, current students, community influences, philanthropists/potential donors and employees. Results showed that 83% of middle school and 100% of high school students surveyed had heard of Collin College. The numbers change when the question becomes that of high quality of education, with 9% of middle school students strongly agreeing and 34% agreeing, while 78% of high school students agree.

The tagline for *Campaign 2015* is PROMISE. POWER, PRIDE. It will include an advertising concept featuring alumni with hashtags such as the example of an ad with former student and current Broadway star Michael Urie: hashtag #actor #broadwayhit #tvstar #collincollegealum. The proposed tactics for the campaign include an internal campaign; middle school initiative during college week; publications including newsletter alumni edition and redesign; a recruitment marketing plan; videos: recruitment and social media; traditions such as songs, hand symbol, flag, cupcake, etc.; and community relations.

Vice President Vasquez closed her presentation with a picture of a bluebonnet that had bloomed from the thousands of seeds planted on campuses. She announced the Founder's Day events to be held on April 6, the exact date of the founding of the college by the approval of voters. Events include everyone wearing blue, a drone video and photos of the number 30 formed by students, faculty and staff all wearing blue, and a media blast.

2015-3-2-1 Personnel Report for March 2015

Upon motion of Mr. Rodriguez, seconded by Ms. McCall, the Board of Trustees of Collin County Community College District unanimously approved Items 1a through 1c, faculty contracts, of the Personnel Report for March 24, 2015 as presented.

On motion of Mr. Cone, second of Ms. Wurzman, the Board of Trustees of Collin County Community College District unanimously approved Items 1d through 1f of the Personnel Report for March 24, 2015 as presented.

Interim President Colleen Smith explained the process regarding faculty contracts that is robust and unique to Collin College. That process includes in-class observation, evaluation by students, and a peer review process; a process that faculty take seriously. The Board Reports provided by the faculty are truly amazing. Dr. Smith recognized Council on Excellence (COE) Chair Mindi Bailey and the members of COE who were present and thanked them for their work and for always putting students first. She said the COE not only takes its role seriously, it strives to make Collin College the best it can be. The COE holds training sessions for faculty, completes a very thorough review of each faculty, and spends countless hours on the process. She concluded by saying the COE and the process represent standards of excellence to the academic community and that she proudly recommends the following faculty contracts for the board's approval.

Mr. Rodriguez said that in reading the faculty board reports, he was impressed with the faculty's service to the college, students and community. Mr. Cone said that after having taught for 19 years, it was wonderful to see the faces of the faculty that the students were sent to at the college. He added that we should never forget the reason that students have their baccalaureate degrees is because of the faculty like those at Collin.

Dr. Collins said he often talks about the faculty at Collin College and that they are like none we have ever seen before. He said good teachers do not just have careers, but they have a calling. He said he appreciated the faculty for the special job that they do and that it is very impressive to see how far Collin has come. Mr. Wainwright said the reason Collin has over 55,000 students is its quality faculty.

Interim President Smith acknowledged the retirement of Sharon Steele-Blakeman. She said that under Sharon's leadership, the ACCESS program had grown not only in ways that the college complies with federal mandates, but in how we support the needs of students. Students have a lot of issues and the program has done tremendous work in supporting students, in helping us all understand what we can do to help, and in helping students meet their potential. Dr. Smith wished Sharon well in her retirement.

Interim District President Smith announced the following:

1. The new Forces publication has been distributed. Thank you to the faculty, students and staff who submitted works for the publication and to our Public Relations department for their work. Scott Yarbrough is the editor and does a beautiful job. It is an amazing publication and the writing and photography are more beautiful each year. There will be a reading of the works on Wednesday, March 25 at the Spring Creek Campus.

2. Congratulations to student Crystal Martinez who received the 2015 NODA Region IV "Outstanding Undergraduate Student - Two Year Institution" award. NODA is the Association for Orientation, Transition and Retention in Higher Education and Region IV covers Texas, Arkansas, Missouri, Kansas and Oklahoma. This is the second year in a row a Collin College student has won the Two Year Institution category. A special thanks to Coordinators Stephen Rogers and Liz Howard for nominating Crystal for this award.

3. Even though the weather caused cancelation of several book-in-common events, 376 people attended the author presentation, book signing and writers' workshop held at PRC and SCC during the first week of March. Special thanks go to District Chair Betty Bettacchi and committee members Dr. Lisa Kirby, Dr. Delores Zumwalt, Catie Brooks, and Charlene Green for their leadership of the program.

4. Almost 400 people attended *Rock the Vote* events at the Spring Creek and Central Park Campuses in late February. Unfortunately, the Preston Ridge Campus event was canceled due to inclement weather; however, we were pleased with the number of students and others who were able to participate at SCC and CPC. Thank you to Vice President Dani Day, Director of the Center for Scholarly and Civic Engagement Dr. Terry Hockenbrough, representatives from Student Life and our students who volunteered to make this a successful initiative.

5. Collin College was well-represented at the most recent annual conference of the Texas Association for Institutional Research (TAIR). Three different presentations from our Institutional Research department were selected by the conference committee and presented by Dr. Tom Martin, Nasreen Ahmad and David Malone. Much appreciation goes to Dr. Martin and the IRO staff.

6.
