PROGRAM ADDENDUM
to
MASTER CLINICAL AFFILIATION AGREEMENT BETWEEN
LAMAR UNIVERSITY
AND
CROSBY INDEPENDENT SCHOOL DISTRICT

WHEREAS, this Program Addendum is made effective on Tuesday, August 18, 2026 between Lamar University and Crosby Independent School District.

WHEREAS, Lamar University, and institution of higher education in the State of Texas and a component of the Texas State University System ("University"), which is located at 4400 S. MLK Parkway, Beaumont, Texas 77710 and Crosby Independent School District ("Facility"), which is located at 14670 FM 2100, Crosby, Texas 77531. University and Facility shall be known collectively as "the Parties" and singularly as "a Party" or "the Party."

WHEREAS, University and Facility desire to implement the provisions of this Program Addendum to the existing Master Affiliation Agreement ("Agreement") dated August 18, 2026, by providing students enrolled in University's Counseling and Development, School Counseling program with educational and clinical experience utilizing the personnel, equipment and facilities of Facility.

NOW THEREFORE, subject to the terms, conditions and provisions of this Program Addendum to the Agreement, the Parties agree as follows:

PROGRAM

Facility is a Texas Independent School District engaged in public education.

University has established and sponsors a Counseling and Development, School Counseling program for students and seeks to educate students by providing and coordinating educational and clinical practice sites for qualified students for the completion of the training offered by the University, subject to applicable accreditation standards and regulations.

The University's program is a 30-month program designed to prepare students for a career as School Counselors.

Standards for the program include requiring students to earn field experience hours during their practicum and internship courses.
