**CONSIDER ORDER  
AUTHORIZING THE  
ISSUANCE OF  
UNLIMITED TAX  
REFUNDING BONDS**

Cameron Wiley made a motion to approve the order delegating to Superintendent Joey Light the authority to price and sell the refunding bonds at a later date so long as each parameter in Section 2(b) is met:

- the maximum par amount of bonds that may be sold is \$29,600,000 (we will not issue more bonds than the amount being refunded);
- the maximum maturity date is February 15, 2038 (we will not extend the maturity of any bonds past their original maturity

date)

- the maximum interest cost may not exceed 5.00%);
- the refunding must produce a minimum net present value savings of 3.00% (a standard threshold)
