To Denton CAD Jurisdictions,

The Texas Legislature passed HB 3121 and voters approved a Constitutional Amendment that extends from 175 days, in the current Freeport Exemption (FP), to up to 730 days for "aircraft parts".

If your jurisdiction wishes to grant this extension for "aircraft parts" you must follow one of the following:

- 1. If you already allow the FP, you must officially adopt the "aircraft parts" FP before June 1 and notify Denton CAD by July 1 of your action; or,
- 2. If you do not currently offer the FP, you must take official action to offer the FP, then follow step 1 above.

Attached is a list of Denton CAD jurisdictions that currently offer the FP.
