WORK SESSION: The Board discussed the leadership structure of the District with a few minor clarifications.

REGULAR SESSION: President Smith called the regular session to order at 7:00 p.m. Mr. Busenbark offered prayer. Mr. Bench led the Pledge of Allegiance to the Flag of the United States of America.

AGENDA, MINUTES: Mr. Bench moved and Ms. Wells seconded to approve the minutes of the regular board meeting held March 7, 2024 and special meeting on March 14, 2024; voting was unanimous in the affirmative.

RECOGNITION: Diana Hanke reviewed the Battle of the Books competition, introduced the winners from each grade, and they shared their favorite book and performed a battle for the Board. The community partner award was presented to V6 media and the Extra Degree award was presented to Renae Allred and Kale Cloward for their exceptional contributions to student success.

ADMINISTRATIVE REPORTS: Scott Forsyth, Roosevelt Jr. High Principal, reviewed their goals, progress, and plans. Attendance is up 7%, they started a Rachel's challenge student kindness group, and behaviors have improved significantly. The District's new behavior matrix has been a great help.

OPEN TIME: At 7:46 p.m. President Smith opened the meeting for public comment. Vickie Jessen noted she had a long message and would email it to the Board instead. Julie Seeley expressed her reasons for being involved in the Altamont four-day schedule and her concerns about the change. Sharon Smith expressed concern for special education students and the change to the four-day week. President Smith closed open time at 7:56 p.m.

- 2. <u>Buildings</u> Superintendent Young reported Duchesne High was progressing and Altamont High shops would start in a few days.
- 3. <u>Policy 2nd Reading: 2.0500.01 .03 Parking and Traffic on School Grounds</u> Superintendent Young noted the change in language to allow but not require the policy as needed at each school. Mr. Bench moved to approve. Mr. Busenbark seconded; passed unanimously.
- 4. <u>Secondary English Language Arts Textbook Adoption</u> Superintendent Young noted a step forward as this would provide a more systematic approach. Kendra Embleton reported on some of the details and how the materials work and would support teaching. Mr. Bench moved to approve. Mr. Thacker seconded; passed unanimously.
- 2024-2025 Trustlands Plans Mr. Busenbark noted concern to make sure new teachers are made aware of
 these funds and how they could have access to the funds through the community council. Mr. Bench noted
 the flexibility with the funds to meet the needs of each school individually. Mr. Bench moved to approve.
 Mr. Thacker seconded; passed unanimously

 - a. Superintendent and Business Administrator appointment Mr. Bench moved to appoint Jason Young, Superintendent of Schools, and Dee E. Miles, Business Administrator for two-year terms starting July 1, 2024. Mr. Thacker seconded the motion; passed unanimously.

1. Superintendent Young highlighted a few of the key bills passed by the Legislature including extensive new school safety measures.
