AGENDA ITEM: Consider Approval of Competitive Sealed Proposal Bid for 2019 Bond Project: Vandagriff Elementary School Conversion to Early Childhood Academy

BACKGROUND INFORMATION:

- During the August 31, 2020 board meeting, the Board of Trustees approved the Competitive Sealed Proposal (CSP) procurement method for the Vandagriff Elementary School conversion to Early Childhood Academy construction project.
- Following this action of the Board of Trustees and pursuant to Texas Government Code Chapter 2269, the following steps were undertaken by the District:
 - Released CSP 22-011422 on January 14.
 - o Conducted a Pre-Proposal Meeting for interested parties on January 17.
 - Received six (6) Competitive Sealed Proposals by the time/due date of 2:00 PM on February 7.
 - Based on evaluation criteria included in the CSP, the Evaluation Committee reviewed and scored/ranked each response received.
 - Notified the highest scored/ranked firm of their selection for final negotiation of a contract.
- Based on the information learned from the steps outlined above and discussions with PBK, the Administration and PBK recommends awarding the contract for the Vandagriff Elementary School conversion to Early Childhood Academy construction project to RJM Contractors, Inc.
- The District was very pleased with the number and quality of contractors submitting responses to the CSP. After thorough analysis and much discussion, the Administration and PBK concluded that RJM Contractors, Inc. provides the best value to the District to ensure timely completion of this project.

FISCAL INFORMATION:

The cost of \$1,300,000.00 (RJM bid cost of \$1,241,442.00 plus an owner's contingency amount of \$58,558.00) is within the construction budget allocated for the Vandagriff Elementary School conversion to Early Childhood Academy project and will be paid with 2019 Bond Funds.
