RESOLUTION AUTHORIZING THE ADOPTION OF THE CERTIFICATE OF TAX LEVY

WHEREAS, Article 17 of The Illinois School Code [105 ILCS 5/17-1 et seq.] authorizes the Board of Education, East Aurora School District 131, Kane County, State of Illinois, to levy taxes for various purposes:

WHEREAS, the Tax Year 2025 levy was estimated on the 6th of October, 2025 which was not less than twenty (20) days prior to the official adoption of the aggregate tax levy of the district;

NOW, THEREFORE, BE IT RESOVED by the Board of Education of East Aurora School District 131, Kane County, Illinois as follows:

<u>Section 1</u>. The Board of Education of East Aurora School District 131 determined that the sum required to be levied by fund, as indicated on the Certificate of Tax Levy attached and made a part of this document, shall be raised on the equalized assessed valuation of the taxable property of said District for the year 2024 as follows:

- a. The sum of \$19,000,000 to be levied as a special tax for Education purposes; and
- b. The sum of \$7,350,000 to be levied as a special tax for Operations & Maintenance purposes; and
- c. The sum of \$5,600,000 to be levied as a special tax for Transportation purposes; and
- d. The sum of \$485,000 to be levied as a special tax for Working Cash purposes; and
- e. The sum of \$1,000,000 to be levied as a special tax for Illinois Municipal Retirement Fund purposes;
- f. The sum of \$3,900,000 to be levied as a special tax for Social Security purposes; and
- g. The sum of \$2,350,000 to be levied as a special tax for Special Education purposes;

<u>Section 2</u>. The Superintendent, Chief Financial Officer, and Township Treasurer are hereby authorized and directed to take any action necessary to file this levy with the County Clerk and to have the taxes specified herein extended.

AND BE IT FURTHER RESOLVED that the President and Secretary are hereby authorized and directed to sign the Certificate and file or cause the same to be filed with the County Clerk of Kane County, State of Illinois on or before the last Tuesday in December of 2025.
