12.a. Special Programs

12.a.1. Service Coordinators Presentation

The Board heard from Healthy and Equitable Schools administrator Sandy Mummey and the 4 Service Coordinators that serve in each area of the district. These coordinators help students and families with facilitating services, be it inside the school, community, or county. The team talked about the Service coordinators pamphlet that is in the Board Packet. Assistant Superintendent Susan VanLiew spoke about how thankful building administrators are for all that the Service Coordinators are doing.

12.b. Facilities & Maintenance/Transportation/Food Services

12.b.1. Newport High School East Boilers

Rich Reported that the district is needing to replace the boilers at Newport High School. He talked about a couple revenue streams that will help pay for those boilers including state and local sources.

Chair Martin entertained a motion to allow Tom Stevens Boiler to be the single source contractor that replaces the boilers at Newport High School at an estimated cost of \$350,000. The motion was set forth by Board Member Rawles, seconded by Board Member McKinley. The motion passed unanimously.

# 12.c. Board

12.c.1. Public Comment (This time is reserved for general public comment to the Board) The Board heard from a Lincoln City community member through the blue card process. He was concerned with education as a nation. He noted that in his travels to China it became clear that we were "behind". He believes that the district has too many administrators and with the recent raise given to Superintendent Gray, was there any plan to increase pay for teachers. Dr. Gray responded that all staff get a salary increase each year and that the district bargains with the association about every two years. The community member also asked about curriculum being taught in LCSD and Dr. Gray extended an invite to him to meet with her in the new year.
