Rankings

Twenty-two vendors submitted proposals for Maintenance Department Supplies and Repair Parts Catalog. There were nineteen categories requested. Criteria to achieve the rankings were specified in the proposal document and follows:

It is not the policy of ECISD to award contracts based solely on “low bid/proposal”. \*The following criteria are used by ECISD to evaluate the overall “best value”:

1. The purchase price; 70 pts
2. The reputation of the vendor’s goods or services; 10 pts
3. The quality of the vendor’s goods or services; 10 pts
4. The extent to which the goods or services meet the district’s needs; 5 pts
5. The vendor’s past relationship with the district; 2 pts
6. The impact on the ability of the district to comply with the laws and rules relating to historically under-utilized businesses; 1pt
7. The total long-term cost to the district to acquire the vendor’s goods and services; 1pt;
8. Any other relevant factor specifically listed in this RFP; 1pt.
