This position is a non-tenure track, non-faculty position. Your employment with the University is at-will, contingent on continued funding, and conditional upon our receipt of all documentation that demonstrates legal eligibility to work in the United States and including passing a criminal background check. The compensation does not include benefits but will include social security, unemployment compensation, and worker's compensation as required by law.

As a part-time employee, you will be provided:

- Information from the department chair or discipline coordinator on course content expectations;
- A list of department procedures for the use of copiers, purchase of class supplies, and other class support;

- A UTPB e-mail address for communication with students.

Acceptance also allows the University to list your name in course schedules and in other publicity as the instructor for the course(s) shown above.
