After careful review and meetings held with upper management regarding the tabulation information provided by your staff, for JOC 2016-006 Trautmann Elementary School Kitchen HVAC System, I recommend the approval of the proposal submitted by Leyendecker Construction of Texas, Inc. in the total amount of \$163,000.00, for the revised total base bid & contingency allowance as the best proposal meeting project's specifications.

Leyendecker Construction of Texas, Inc. submitted an initial proposal for the total base bid (including a contingency allowance of \$15,000.00 for District use and approval only) in the amount of **\$168,000.00**, but after further negotiations by the Purchasing Department, Leyendecker Construction of Texas, Inc. reduced their proposal to a best and final amount of \$163,000.00, a reduction in the amount of **\$5,000.00**.

Leyendecker Construction of Texas, Inc. best and final revised total base bid proposal was in the amount of \$148,000.00 plus a contingency allowance in the amount of \$15,000.00, for a total amount of \$163,000.00.
