#### ACTION

#### BACKGROUND INFORMATION:

State statute requires that changes in the Budget adopted by the School Board at their June 2012 meeting and amended at their October 15, 2012 meeting, the January 14, 2013 meeting (which included both Budget Amendment 2 and the transfer of funds from Fund Balance), the March 18 meeting, and the April 8 meeting, must be approved by the School Board if they change the major revenue sections of the budget or if they move money between expenditure functions.

The attached budget amendment being submitted to the board makes the following changes to the budget:

- To increase both the Other Revenue and Maintenance Expense budgets by \$1,300 for a gift received from the River Road High School Booster Club. The gift is to be used to install a roll-up door/window in the room at the west end of the Commons which will allow the booster to sell concessions without using the kitchen.
- To increase both the Other Revenue and Maintenance Expense budgets by \$58,045 for a check received from our insurance company to complete the settlement of the water damage claim at Willow Vista. \$2,881 will be used to reimburse the district for employee time spent on the clean-up. The remainder will be paid to H2O Solutions. The insurance also paid H2O Solutions \$143,323.31 directly as part of the claim settlement.

In both cases, there is no affect on the budget because both revenue and expense was increased equally.

## BOARD ACTION REQUESTED:

We request that the Board approve the General Fund Budget Amendment #6 for the 2012-2013 budget as presented.
