During the 2021-2022 school year, many LEA's have experienced losses in average daily attendance (ADA) due to low rates of attendance caused by the ongoing COVID-19 pandemic.

ADA is a major component in determing school funding. To mitigate against these reductions in Foundation School Program funding, the commissioner is offering a one-time adjustment solely for funding purposes. This adjustment does not hold LEA's harmless for losses of ADA due to enorliment declines. This will be finalized in September 2022 settle up payments.
