Proposed Handbook Amendments:

- I. Revisions:
 - A. TAs move from .25 credit to .5 credit (pp.7) to align with all other semester electives.
 - B. PE Waiver pp. 12 removal of language "The purpose of the substitution is to allow the student to take a course not otherwise available because it conflicts with the schedule for PE courses." All other language regarding substituting one full season of varsity athletics for .25 credits of PE will remain the same.
 - C. Alcohol and other controlled substances (pp.14)
 - Remove the language that reads: "Re-admittance will require the completion by the student of a drug and alcohol evaluation screening by an appropriate individual organization" and "a student will have as a condition of continued school attendance his/her participation in specified drug education program" as outside of school's purview — this is apart from TAD policy.
 - D. Dates to dances: Another school must provide a chaperone to dances at Craig High School (pp. 15)
 - 1. Revise language on line three to read: "A guest form must be filled out 5 days before the event that states the student agrees to abide by CHS rules at the dance. This form must also be signed by the guest's school principal to guarantee the guest is in good standing at their home school."
 - 2. Remove the language on line six that reads: "Any student not from CHS attending a Craig High School dance must have a chaperone from that school present.
 - E. Dress Code:
 - Midriff rewording is based on fashion changes, particularly high-waisted pants. The current wording is "Revealing clothing is not allowed including but not limited to the following: 1. Any shirt or top that ends above the waistband." The proposed new wording would read: "1. More than one inch of exposed midriff."
 - F. Detentions (pp. 22)
 - 1. Change the first sentence to read: Detention is a staff-imposed consequence for a minor infraction of classroom or school rules per the discipline grid.
 - 2. Change the third sentence to read: detention assigned by other staff or the office will be served with the student's class advisor or in the office as arranged.
