## A. ACTION ITEM Disc Golf Sponsorship

Suzie mentioned that she received an email from Commissioner Spendlove indicating that a \$1,000 check will be coming soon from two different sponsors. The Spokane based company is scheduled to start building the disc golf course next week. Suzie has notified the Broadmoore Park HOA and suggests we put it on Facebook as well as the City's website. The total cost to build is now \$6,500 due to the increase costs in building supplies. The city has received \$2,500 from several sponsors, plus the \$2,000 still to come. Vice-Chair Sampsel will contact Northwest Specialty Hospital as well as Axis Spine for possible donations. Chair Troxel will contact Tri-State Outfitters. The commission would like Lori to contact Commissioner Spendlove to see who all she has reached out to. Suzie will look to see exactly which sponsors have paid.

Hours are 4:00-8:00pm on December 3<sup>rd</sup> and 10:00am-6:00pm on December 4<sup>th</sup>. There will be German/European food, vintage craft vendors, hot mulled wine or cider, propane fire pits and more. She has many volunteers but can always use more. She will be providing security during each day and overnight. She is working closely with the city on all of the details. The Civil Air Cadets will be assisting with garbage, parking and set-up and take down. Commissioner Johnson mentioned that his Young Marines group may possibly also volunteer. He will contact Andrea to discuss further. The Commission is in support of this fun event.
