## The Board of Trustees Beeville ISD

A Special Meeting of the Board of Trustees of Beeville ISD was held Tuesday, August 25, 2015, beginning at 5:30 PM in the Board Room at 201 N. St. Mary's, 2nd Floor, Beeville, TX 78102.

1. Call to Order: 5:31 PM

- 2. Conduct Public Hearing on 2015-2016 Budget and Proposed Tax Rate
  - A. 2015-2016 Budget
  - B. 2015-2016 Proposed Tax Rate Consultant for School Administration & Finance Doug Arnold and School Business Specialist Janel Wilson of ESC2

## 3. Action Items:

A. Consideration and Possible Approval of 2015-2016 Proposed Tax Rate Kevin Behr made the motion to approve the 2015-2016 Proposed Tax Rate of \$1.04 Maintenance and Operations and \$0.1654 Debt for a Total Tax Rate of \$1.2054. The motion was seconded by Leticia Munoz.

Kevin Behr then made the motion that the Property Tax Rate be increased by the Adoption of a Tax Rate of \$1.2054. The motion was seconded by Viola Maldonado.

After discussion about the motion language on the Action Sheet provided; Kevin Behr made the motion to approve the 2015-2016 Proposed Tax Rate of \$1.04 Maintenance and Operations and \$0.1654 Debt for a Total Tax Rate of \$1.2054; and that the Property Tax Rate be increased by the Adoption of a Tax Rate of \$1.2054.   John Fish made the motion to approve the Designated Fund Balance as
  Assigned. (\$739,258 is assigned to the Superintendent to be used at his/her
  discretion.) The motion was seconded by Viola Maldonado and carried by
  unanimous.
- D. Consideration and Possible Approval of 2014-2015 Amended Budget Viola Maldonado made the motion to approve the 2014-2015 Amended Budget. The motion was seconded by Eddie Salazar and carried by unanimous vote.
