### RESOLUTION TO LEVY TAXES FOR ILLINOIS MUNICIPAL RETIREMENT, SOCIAL SECURITY, SPECIAL EDUCATION AND FIRE PREVENTION AND SAFETY PURPOSES

WHEREAS, Sections 7-171 and 21-110 of the *Illinois Pension Code* {40 ILCS 5/7-171 and 5/21-110} authorize the Board of Education, Nippersink School District 2, McHenry and Lake Counties, Illinois, to levy, by proper resolution, an annual tax for Illinois Municipal Retirement and Social Security purposes; and

WHEREAS, Section 17-2.11 of the *School Code* {105 ILCS 5/17-2.11} authorizes the Board of Education, Nippersink School District 2, McHenry and Lake Counties, Illinois, to levy, by proper resolution, an annual tax for Fire Prevention and Safety purposes; and

WHEREAS, Section 17-2.2a of the *School Code* {105 ILCS 5/17-2.2a} authorizes the Board of Education, Nippersink School District 2, McHenry and Lake Counties, Illinois, to levy, by proper resolution, an annual tax for Special Education Program purposes.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF EDUCATION, NIPPERSINK SCHOOL DISTRICT 2, MCHENRY AND LAKE COUNTIES, STATE OF ILLINOIS, AS FOLLOWS:
