**Report/Discussion Items**

**24835** **Report on Recent Community Tragedy:** Superintendent Dr. Scott Muri offered a report on the recent community tragedy. He expressed the importance of the need for everyone to take care of themselves in the wake of this tragedy. He thanked

ECISD Police, District Leaders, and Principals for the way they stepped up and worked throughout the week to make sure kids and families were taken care of when they returned to school. He reassured Trustees the district is working with many local agencies and organizations to build a coalition that will support our community's recovery in the coming weeks, months, and years. Trustees expressed their gratitude for the work by District staff, local agencies and the surrounding communities that stepped in to help in many different ways.

**24836** **Campus Improvement Plans:** Executive Director of Elementary Leadership Alicia Press along with Executive Director of Secondary Leadership Roberto Cedillo presented the Campus Improvement Plans. Over the spring semester the creation of the District Improvement plan began with a complete data analysis. This work involved the entire District Leadership Team. As the group developed the District's plan, the campus plans were aligned with the same goals. District Leaders also discussed Bonham Middle School, which is in its fourth year of Improvement Required status. Specific goals and monitoring are in place to bring improvement.

**24837** **Discussion of ECISD's Vision:** Superintendent Dr. Scott Muri presented this item for discussion. The Board developed the school district vision ***OUR Students....The Future***, during the strategic planning process in the spring before the hiring of Dr. Muri. Trustees shared their vision of the desire to build successful children who become successful adults – whatever that might mean for that individual child. Trustees also spoke about forming partnerships with parents, supporting teachers and principals with needed resources, and setting high expectations for everyone, including themselves.
