B. Fund 211 – User Surcharges Update – Carrie DePuy gave an overview of Fund 211. The ending balance as of June 30, 2023, is \$632.358.67 and the Turf Field Reserve balance is \$451,415.62. The field usage fees we charge are very low. Quotes to replace the turf field and track that were obtained in 2022 have not been updated. This is the second turf field, as the original turf field was replaced under warranty. The track is also in poor shape. Both the field and track may have to be replaced in the next 5 years.

## IV. INFORMATION/ACTION ITEMS

A. Board of Education Policy 1330 – Appendix A & Appendix B – Appendix B was reviewed and discussed. A majority of users of our fields pay the rate that is noted on the farright hand column are New Fairfield groups. Carrie DePuy will have a list of fees that other districts charge for the next meeting to see how we compare. A handful of outside teams use our fields at the higher rate. It was agreed that the fees charged may have to be increased. Some groups pay for one field and use multiple fields. Field usage is a difficult thing to manage and is run on the honor system. Insurance documents may be a way to track the number of users of our fields.
