Description: Imagine Math K-5th is an online math platform that provides students with an individualized learning pathway based on a pre-assessment that identifies gaps in conceptual understanding and identifying enrichment for learners who are ready to move forward. Imagine Math provides students with math instruction at their ability level and guides them on the path to success with standard mastery through a multi-level instructional support, progress monitoring and live reports our teachers can use on the spot to provide feedback and drive instruction.

Historical Data: Imagine Math was an excellent virtual tool used during Covid with our 3rd-5th grade students. In 2021-2022 Imagine Math was purchased for our Kinder-2nd and 3rd-5th grade students. Students who successfully completed their weekly lesson goals showed significant gains in their math skills on the state assessments. We stopped using Imagine Math to purchase another platform that would sync the universal screener; MAP. This year, Imagine Math has updated their platform to also sync to both MAP and our K-5th math curriculum known as Eureka.
