Resolutions (Action Item)

NSBSD Strategic Plan Goal:

2.0 Community Engagement: Foster collective responsibility, commitment, and trust between the school and community.

Issue Summary:

The Association of Alaska School Boards (AASB) is soliciting resolutions, resolution amendments, and comments from local school boards for consideration at the 2023 Annual Conference on November 9-12, 2023 in the Anchorage Hilton Hotel. The deadline to submit resolutions is October 10, 2023.

The Legislative Committee did not recommend any new resolutions or amendments at this time; however, is recommending administration identify the original district author of Resolution 5.9, Urging flexibility in testing requirements to support indigenous language programs, and propose additional language providing data and solutions supporting the resolution. With the deadline to submit resolutions and amendments occurring before the next regular meeting, the recommendation is to authorize the committee final approval of resolutions and/or amendments for the AASB Where We Stand draft submission for the delegate assembly of AASB.

Background:

The resolution committee will meet on Thursday, November 9, 2023 to review the resolutions to be adopted by the membership at the Delegate Assembly on November 12, 2023.

AASB asks each school board to carefully review the resolutions packet and advance only those resolutions or amendments that they deem necessary. The AASB Board of Directors recommended the renewal of all resolutions currently scheduled to sunset and are not recommending any new resolutions. The resolution submissions from across the state will be available for review beginning Saturday, October 21, 2023, 20 days before the annual conference. Only the title and resolution are voted on by the AASB membership, not the rationale.

Recommendation:

The Legislative Committee is recommending administration identify the original district author of Resolution 5.9, Urging flexibility in testing requirements to support indigenous language programs, and authorize the committee final approval of resolutions and/or amendments for the AASB Where We Stand draft submission for the delegate assembly of AASB.
