A. Day to Day Lives of Extraordinary People Vol I **Action Item**

Chair Eichelberger passed out a list of families that will be showcased in Vol. 1. Several updates such as Mr. Humphries was a guard for German POWs at Farragut and C.B. King requiring quite a bit of work to sort out. Commissioner Zink asked if the families have been completed and forwarded to Sabrina. Chair Eichelberger responded that most are done and have been forwarded but she has not had feed-back from Sabrina to know if they were received..

Vice Chair Bennett communicated that the Buckles family has been very difficult to get information but she will persist until she has them completed. Updates included son Joseph had property at Emerald Estates and Frank owned property off Honeysuckle. Frank arrived on his honeymoon but moved to Canada when his wife had an affair. She is currently working on completing the Hickey family and Sargents. The new owner of Sargents Restaurant wants pictures for the new part of the restaurant showing history of the establishment. The interpretive signage was not on the agenda, however, Commissioner Zink handed out plans for construction of the signs. Mrs. Phillips said the verbiage was given to Brett for approval. She is currently looking into watermarks and Q.R. codes which would take people to more complete stories of the orchards. It was suggested that pictures be taken at the old Pillar Place for inclusion. Mrs. Phillips questioned Commissioner Zink as to whether a sign company had been contacted.
