TOPIC: RATIFY 2016-18 FOOD SERVICE BARGAINING UNIT SEIU

LOCAL 284 AGREEMENT

BACKGROUND: The contract between Forest Lake Area School District #831 and the Food Service Employees expired on June 30, 2016.

PROCESS: The School District and the Food Service employees have a tentative settlement of the contract for the time period July 1, 2016 to June 30, 2018. The Food Service Employees have voted positively to ratify this contract and it is now being presented to the School Board for approval.

RECOMMENDATION: Administration recommends approval of the Food Service Bargaining Unit SEIU Local 284 Agreement for July 1, 2016 to June 30, 2018.

ARTICLE I PURPOSE

Section 1. Parties: THIS AGREEMENT is entered into between the School Board of Independent School District No. 831, Forest Lake, Minnesota, (hereinafter referred to as the School Board or School District), and the School Service Employees International Union (SEIU) Local 284, (hereinafter referred to as the exclusive representative or union) pursuant to and in compliance with the Public Employment Labor Relations Act of 1971, as amended, (hereinafter referred to as the PELRA) to provide the terms and conditions of employment for food service employees during the duration of this Agreement.

ARTICLE II RECOGNITION OF EXCLUSIVE REPRESENTATIVE

<u>Section 1. Recognition:</u> In accordance with the PELRA, the School Board recognizes the School Service Employees International Union (SEIU) Local 284, as the exclusive representative for food service personnel employed by the School District, which exclusive representative shall have those rights and duties as prescribed by the PELRA and as described in the provisions of this Agreement.

<u>Section 2. Appropriate Unit:</u> The exclusive representative shall represent all such employees of the School District contained in the appropriate unit as defined in Article III, Section 2 of this Agreement and the PELRA and in certification by the Director of Mediation Services, Case No. 13-PCE-0249.

ARTICLE III DEFINITIONS

<u>Section 1. Terms and Conditions of Employment:</u> Terms and conditions of employment means the hours of employment, the compensation therefor, including fringe benefits, except retirement contributions or benefits, and the employer's personnel policies affecting the working conditions of the employees.

Section 2. Description of Appropriate Unit: For purposes of this Agreement, the appropriate unit shall mean food service employees, excluding the following: confidential employees, supervisory employees, essential employees, part-time employees whose services do not exceed twelve (12) hours per week in the employee bargaining unit, employees who hold positions of a temporary or seasonal character for a period not in excess of 67 working days in any calendar year and emergency employees.

<u>Section 3. School Board or School District:</u> Any reference in this Agreement to the School Board or School District shall mean the School Board or its officials designated by the School Board to act in its behalf.

Section 4. PELRA: PELRA shall mean the Public Employment Labor Relations Act of 1971, as amended.

Section 5. Other Terms: Terms not defined in this Agreement shall have those meanings as defined by the PELRA.

ARTICLE IV SCHOOL BOARD RIGHTS

<u>Section 1. Inherent Managerial Rights:</u> The exclusive representative recognizes that the School District is not required to meet and negotiate on matters of inherent managerial policy, which include, but are not limited to, such areas of discretion or policy as the functions and programs of the School District, its overall budget, utilization of technology, the organizational structure and selection and direction and number of personnel.

<u>Section 2. Management Responsibilities:</u> The exclusive representative recognizes the right and obligation of the School District to efficiently manage and conduct the operation of the School District within its legal limitations and with its primary obligation to provide educational opportunity for the students of the School District.

Section 3. Effect of Laws, Rules and Regulations: The exclusive representative recognizes that all employees covered by this Agreement shall perform the services prescribed by the School District and shall be governed by the laws of the State of Minnesota, and by School Board rules, regulations, directives and orders, issued by properly designated officials of the School District, insofar as such rules, regulations, directives and orders are not inconsistent with the terms of this Agreement. All provisions of this Agreement are subject to the laws of the State of Minnesota, federal laws, rules and regulations of the State Department of Education, and valid rules, regulations and orders of state and federal governmental agencies. Any provision of this Agreement found to be in violation of the state or federal laws shall be null and void and without force and effect.

<u>Section 4. Reservation of Managerial Rights:</u> The foregoing enumeration of School District rights and duties shall not be deemed to exclude other inherent management rights and management functions not expressly reserved herein, and all management rights and management functions not expressly delegated in this Agreement are reserved to the School District.

ARTICLE V EMPLOYEE RIGHTS

Section 1. Rights to Views: Pursuant to the PELRA, as amended, nothing contained in this Agreement shall be construed to limit, impair or affect the right of any employee or his/her representative to the expression or communication of a view, grievance, complaint or opinion on any matter related to contract administration and the conditions or compensation of public employment or their betterment, so long as the same is not designed to and does not interfere with the full, faithful and proper performance of the duties of employment or circumvent the rights of the union.

Section 2. Right to Join: All qualified employees shall have the right to form and join labor or employee organizations and shall have the right not to form and join such organizations. Employees in an appropriate unit shall have the right by secret ballot to designate an exclusive representative for purposes of negotiating grievance procedures and the terms and conditions of employment for such employees with the School District of such unit.

Section 3. Request for Dues Check Off: Employees shall have the right to request and be allowed dues check off provided that dues check off and the proceeds thereof shall not be allowed any employee organization that has lost its right to dues check off pursuant to the PELRA, as amended. Upon receipt of a properly executed authorization card of the employee involved, the School District will deduct from the employee's paycheck the dues that the employee has agreed to pay to the employee organization during the period provided in said authorization. Payroll deductions shall begin with the first paycheck in October and conclude with the first paycheck in June and shall be transmitted to the employee organization within fifteen (15) days following said pay period, together with a list of names of the employees from whom deductions were made. For those employees who work twelve months out of the year, dues shall be deducted monthly.

Section 4. Fair Share Fee:

Subd. 1. Pursuant to the PELRA, as amended, employees who are not members of the union may be required by said union to contribute a fair share fee for services rendered by the union, and the School District, upon notification by, shall, pursuant to the PELRA, as amended, be obligated to check off said fee from the earnings of the employee and transmit the same to the union within fifteen (15) days. The fair share fee for any employee shall be in an amount equal to the regular membership dues of the exclusive representative, less the cost of benefits financed through the dues and available only to the members of the exclusive representative, but in no event shall the fee exceed eighty-five percent (85%) of the regular membership dues.

The exclusive representative shall provide written notice of the amount of the fair share fee assessment to the Director, the School District, and to each employee to be assessed the fair share fee. Section 5. Personnel Files: Subd. 1. Personnel files relating to each individual employee shall be available to TA 6/2/17 each individual employee during regular school business hours upon his/her written request. The employee shall have the right to reproduce any of the contents of the files at the employee's expense and to submit for inclusion in the file written information in response to any material contained therein. Subd. 2. An employee shall receive a copy of any deficiency notice placed in TA 6/2/17 his/her personnel file. Subd. 3. The School District may destroy the files as provided by law and shall TA 6/2/17 expunge from the employee's file any material found to be inaccurate or incomplete through the grievance procedure. Section 6. Political Action Committee: Upon receipt of a properly executed voluntary TA 6/2/17 authorization card from an employee, the District will deduct from the employee's salary such amounts as the employee authorizes to pay to COPE. TA 6/2/17 ARTICLE VI DUTY YEAR, DUTY WEEK, HOURS OF SERVICE TA 6/2/17 Section 1. Work Year: TA 6/2/17 Subd. 1. Twelve (12) Month Employees: The work year for twelve (12) month employees shall be twelve (12) months (52 weeks) per year, subject to earned vacation and holidays as prescribed by this Agreement. TA 6/2/17 Subd. 2. Less than Twelve (12) Month Employees: The work year for less than twelve (12) month employees shall be as prescribed by the School District. In the event of extension by the School District of the work year for less than twelve (12) month employees, such employee shall be paid their basic rate of pay. TA 6/2/17 Subd. 3. Assigned Duty Days: Duty days for less than twelve (12) month

employees shall be as prescribed by the School District.

Section 2. Step Increase: Eligible employees shall advance a step pursuant to this agreement July 1, 2014 2016. Eligible employees shall advance a step pursuant to this agreement July 1, 2015 2017.	TA 6/2/17
Subd. 1. In the event a successor agreement is not entered into prior to July 1, 2016 2018, an employee shall remain at the same step as compensated during the 2015-2016 2017-2018 contract year until a successor agreement is reached. A new employee shall be placed on the schedule pursuant to Section 5 hereof and shall be eligible for step advancement on July 1 if commencing work prior to January 1. An employee who commences work after January 1 shall be eligible for any increase in the current step but shall not be eligible for step advancement until July 1 of the following calendar year. Subd. 2. The School Board reserves the right to withhold a step increase in individual cases for just cause. Such increase shall not be withheld unless the employee is notified of the deficiency in writing and given a reasonable opportunity to correct such deficiency.	TA 6/2/17

Section 5. Placement on Schedule:

Subd. 1. A new employee shall be placed on the starting rate of the appropriate salary schedule. A transferring employee shall be placed on the same step in the new classification as occupied on the prior classification. However, the School District reserves the right in special circumstances, to allow placement at a higher step based upon background and experience of the employee either in the case of a new employee or a transferring employee.

Section 1. Selection of Carrier: The selection of the insurance carrier and policy shall be made by the School District.

Section 2. Medical-Hospitalization Insurance - Health Maintenance Organization Plan:

<u>Subd. 1. Single Coverage for Twelve (12) Month Employees:</u> The School District shall pay the premium for single medical-hospitalization insurance for all twelve month employees employed by the School District who are regularly employed forty (40) hours per week for at least 50 weeks per year and are enrolled in the medical-hospitalization plan.

Subd. 2. Dependent Coverage for Twelve (12) Month Employees: The School District shall contribute a sum not to exceed the amounts indicated below per month toward the premium for dependent medical-hospitalization insurance for all full-time employees employed by the school district who qualify for and are enrolled in the medical-hospitalization plan. The cost of the premium not contributed by the School District shall be borne by the employee and paid by payroll deduction.

Single Coverage for Less Than Twelve (12) Month Employees: The School District shall contribute a sum not to exceed the amounts indicated below per month toward the premium for single medical-hospitalization insurance for all employees employed by the School District at least thirty-five (35) hours per week and a minimum of 170 days per year who qualify for and are enrolled in the medical-hospitalization plan. The cost of the premium not contributed by the School District shall be borne by the employee and paid by payroll deduction.

Effective July 1, 2014 **2016**: \$640.00 per month Effective July 1, 2015 **2017**: \$640.00 per month

Subd. 4. Dependent Coverage for Less Than 12 Month Employees: The School District shall contribute a sum not to exceed the amounts indicated below per month toward the premium for dependent medical-hospitalization insurance for all employees employed by the School District at least thirty-five (35) hours per week and a minimum of 170 days per year who qualify for and are enrolled in the medical-hospitalization plan. The cost of the premium not contributed by the School District shall be borne by the employee and paid by payroll deduction.

Effective July 1, 2014 **2016**: \$720.00 per month Effective July 1, 2015 **2017**: \$720.00 per month

<u>Section 3. Long-Term Disability Insurance:</u> The School District shall provide each regular employee employed at least 15 hours per week and a minimum of 170 days per year with long-term disability insurance coverage. The cost of this insurance shall be borne by the employee and paid through payroll deduction.

<u>Section 4. Life Insurance:</u> The School District shall provide each eligible employee employed at least twenty (20) hours per week and a minimum of 170 days per year with a \$50,000 term life insurance policy. The cost of this insurance shall be borne by the School District.

Dental Insurance: The School District shall pay the premium for single dental insurance for all eligible employees employed by the School District who are regularly employed at least thirty-five (35) hours per week for a minimum of one hundred seventy (170) days per year and are enrolled in the plan.

Section 6. Flexible Benefit Plan: The School District shall sponsor a Flexible Benefit Plan.

Section 7. Claims Against the School District: The parties agree that any description of insurance benefits contained in this Article are intended to be informational only and the eligibility of any employee for benefits shall be governed by the terms of the insurance policy purchased by the School District pursuant to this Article. It is further understood that the School District's only obligation is to purchase an insurance policy and pay such amounts as agreed to herein and no claim shall be made against the School District as a result of a denial of insurance benefits by an insurance carrier.

Section 8. Duration of Insurance Contribution: An employee is eligible for School District contributions as provided in this Article as long as the employee is employed by the School District. Upon termination of employment, all School District contribution shall cease, effective on the employee's last working day.

Such leave may be accumulated up to a maximum of 200 days [up to eight (8) hours per day]. Sick leave may be used pursuant to the provisions of this Article. TA 6/2/17 Subd. 2. Sick leave pay for illness shall be allowed whenever the employee's absence has been due to illness which prevented his/her performance of assigned duties on that day or days. Sick leave may also be used for the serious illness of an employee's child who is under 18 years of age or under 20 years of age and is still attending a

<u>Subd. 1. Level I:</u> If the grievance is not resolved through informal discussions, the Director of Business Services or his/her designee shall give a written decision on the grievance to the parties involved within ten (10) days after receipt of the written grievance.

Level II: In the event the grievance is not resolved in Level I, the decision rendered may be appealed to the Director of Administration and Human Resources, provided such appeal is made in writing within ten (10) days after receipt of the decision in Level I. If a grievance is properly appealed to the Director of Administration and Human Resources, the Director of Administration and Human Resources or his/her designee shall set a time to meet regarding the grievance within ten (10) days after receipt of the appeal. Within ten (10) days after the meeting, the Director of Administration and Human Resources or his/her designee shall issue a decision in writing to the parties involved.

School Board Review: The School Board reserves the right to review any decision issued under Level I or Level II of this procedure at the request of the grievant or at its own instance, provided the School District or the grievant provides written notice within ten (10) days after a decision in Level I or Level II has been rendered. Within ten working days of the response at Level II (or board review, as appropriate), a party wishing to enter grievance mediation shall file a petition for mediation services with the BMS and shall provide a copy of the petition to the other party. If either party requests grievance mediation, timelines for subsequent grievance proceedings shall be temporarily waived. If either party at any time refuses to continue with grievance mediation, that party shall give written notice to the other, at which time the timelines shall resume according to the procedure in this Article. If either party provides such notice, the grievance may be appealed to arbitration in writing within ten (10) days of the notice of discontinuation of mediation. The purpose of grievance mediation is to explore interests related to the grievance and possible ways to resolve the grievance. Accordingly, no offers,

counter offers, or any documentation relating to the grievance mediation shall be used by either party at arbitration. If the parties reach resolution, the agreement shall be put into writing.

The provisions herein relating to terms and conditions of employment supersede any and all prior agreements, practices, school policies, rules or regulations concerning terms and conditions of employment, insofar as such are inconsistent with these provisions. Nothing in this Agreement shall be construed to obligate the School District to continue or discontinue existing or past practices, or prohibit the School District from exercising all management rights and prerogatives defined in this Agreement, except insofar as such exercise would be in express violation of any term or terms of this Agreement.

<u>Section 3. Finality:</u> Any matters relating to the current contract term, whether or not referred to in this Agreement, shall not be open for negotiation during the term of this Agreement. However, this Agreement may be amended at any time by mutual agreement of the parties.
