C. Presentation of Healthy Futures of Texas Grant on Big Decisions Curriculum for Ninth Grade Students

Mr. Mike Garza — Mr. Montemayor, Board Members, members of the audience. As part of the State mandated called the (SHAC) it the charge of the committee to be able to bring forth to the Board some recommendation on student health and activity that we have. Tonight we have two presentations that will be provided to the Board. We do anticipate a lengthy presentation at the April Board Meeting to be able to answer additional questions. There is a time crunch that we have at the end of this week to submit a grant for this funding, so the MOU is of critical nature to be able to get that approved for this week. With that being said, we want to have the first presentation provided to you by Dr. Jan Realini and she is with Healthy Futures of Texas.

Presentation is available upon request.

Juan Roberto Ramirez – Since you started this program what are the results you have obtained.

Dr. Realini – We have had very good responses from parents and students. It is very popular and fun. In the communities that are being used teen pregnancy is coming down.

Aliza Flores Oliveros - For clarification purposes what grade level is this program going to be used for.

Dr. Jan Realini - The program is for 9th grade

Aliza Flores Oliveros - For clarification purposes parents have the option to opt out of participation. This requires parental approval.

Dr. Jan Realini – absolutely – parental approved is required.

Aliza Flores Oliveros – What policy has been affected by this program.

Dr. Jan Realini – State law regarding sex education.

Aliza Flores Oliveros - For clarification purposes part of the program does advocate abstanes.

Dr. Jan Realini – this is first and foremost what we advocate.

Javier Montemayor — What is the percentage of participation? Let's say San Antonio ISD. What is the level of participation at that school and if they are not participating what has been the controversary as to why they don't participate. What kind of feedback have you gotten?

Dr. Jan Realini – Primary reason for not participating in the implementation in San Antonio is that the student did not get the piece of paper home and brought back. It has not been controversial. Of course not all parents won't want it and opt out. SAISD has gone to an opt out because they were disappointed that the child did not get the form.

Mike Garza — Critical component in is this committee is that the SHAC committee is composed of parents, community members, and medical professional. These two presentations were recommended unanimously to the Board. At this moment we are only focused on the deadline fore the application for the funding. A more detailed program will be presented together with the PEP Program to be able to give you the statistics on the actual numbers that we are seeing.

Steven Trautmann – the deadline to enter into the approval of the MOU is Friday. So there is a bit of a time crunch. Our law firm has not had a chance to review these MOU's, so if a motion is made I recommend that is be subject for legal review. We don't see an issue why we cannot review these documents and have them ready by Friday. This would be my recommendation.

Mike Garza - . These are MOU's that have been approved at other school districts.

Aliza Flores Oliveros – Physically, UISD would be participating via student. There will not be a financial responsibility.

Mike Garza – the way the plans are the grant will cover 99% of all the items. Obviously, facilities would be a portion that we contribute; maybe stipends will be paid to some of our staff. All the funds would be coming from these grants. Basically we did not want to lose out on the opportunity. Later on if we decide and the board has that decision to say you know what this is not for us, whatever it is we will figure out at that time.
