#### V. PUBLIC PARTICIPATION

Dawn Lipke thanked the Board of Education and everyone involved in facilitating the Special Education Ad Hoc subcommittee and noted that this has created a positive outcome. Ms. Lipke spoke of the possibility to forming SEPTA (Special Education Parent Teacher Association) and noted that an application can only be submitted by a parent. Ms. Lipke spoke of a discussion at a recent Special Education Ad Hoc subcommittee in which she said the Superintendent claimed that she submitted an application for SEPTA in the past.

Laura Consiglio noted that she also appreciated the work of the Ad Hoc subcommittee but noted that there is still work to be done. She further spoke of the Superintendent's upcoming

evaluation and encouraged the Board of Education members to record scores for her evaluation and to give specific comments for their evaluation.

Craig David Rosen discouraged the Board of Education from renewing the Superintendent's contract and further noted that specific constructive comments should be given to the Superintendent.

- B. Superintendent's Report Dr. Alicia Roy spoke of the following:
  - Congratulated the Girls' Lacrosse team for winning the State Championship.
  - Thanked all the volunteers in the district and especially the PTOs.
  - The SEE Fair was held on Monday, June 5<sup>th</sup> and was very successful with many diverse projects.
  - Congratulated High School Science teacher Edie Mullally and her students Aileen Leon, Sydney Gouveia and Thomas Ciardi for winning prizes in the Energize CT EE Smarts Competition.
  - There is a survey on the district website to see if there is any interest in before or after school care at the elementary schools.
  - Showed the MHHS Literary magazine
  - Congratulated High School teacher Mrs. Main on the 2017 Yearbook.
  - Over \$75,000 worth of scholarships were awarded to High School Seniors at Scholars Night.
  - The High Schools Seniors will march through Consolidated School and Meeting House Hill School wearing their caps and gowns on June 19<sup>th</sup>.
  - Invited everyone to the High School graduation that will be held next Saturday, June 24<sup>th</sup> at 10 a.m. in the O'Neill Center at Western Connecticut State University.

## D. Committee Reports

- 1. <u>Business Operations/Resource Management</u> Ed Sbordone noted that they met this evening and discussed the Budget vs. Actual for the current fiscal year as of May 31<sup>st</sup>. The budget is on schedule and there will be a surplus.
- Special Education Ad Hoc Samantha Mannion noted that the subcommittee met on June 14<sup>th</sup> and discussed programming changes and summer programs. There have been requests for more parent programs in the district. There was a discussion of new state legislation regarding dyslexia.

## E. Liaison Reports

1. <u>Parks and Recreation Committee</u> - Steve Burfeind noted that the commission met on June 12<sup>th</sup> and voted to construct a second basketball court at the playground at the high school.

#### VII. INFORMATION ITEMS

A. <u>Teacher Data Dashboard</u> - Chief Academic Officer Dr. Jason McKinnon and Director of Technology Alison Herold spoke of the progress made with the Data Dashboard that assesses student performance. Dr. McKinnon spoke of the different types of assessments, which allow for feedback from teachers to students. The subjects for these assessments include Math, Reading and Writing. The frequency of these assessments varies based on the subject. Alison Herold spoke of the Admin. Dashboard vs. the Teacher Dashboards and explained how each is used. The dashboard shows different types of filters that highlight students who are struggling and thus allow for early intervention.

Dr. McKinnon spoke of the next steps and the future of the Data Dashboard. He further thanked Alison Herold for all her hard work and expertise with the Data Dashboard.

B. House of Rebel-sentatives and Student Senate Update - Nicole Cennamo, Marcus Mocarski and Jared Przyborowski spoke of the House of Rebel-sentatives and the Student Senate and their role within the high school. These programs have representatives that give the students a safe and welcome environment to air concerns and get feedback regarding issues at the high school. The first official meeting was held last week. Nicole gave an overview of the meetings.
