Nannut Qaqisaurajat, LLC

NSBSD Strategic Plan Goal:

1.0 Student Success: All students will reach their intellectual potential and achieve academic success through integrating Iñupiaq knowledge systems into the core content areas and focusing on the development of the Whole Child.

4.0 Financial & Operational Stewardship: Effectively employ our operational and financial resources to support our strategic goals and long-term stability of the district.

4.2 Financial Stewardship: Ensure financial management based on what is best for our students.

NSBSD Policy Manual:

BP 3311, Bids: All purchases in the amount of \$20,000 or more shall be based, when possible, on three competitive bids. The Superintendent or designee shall establish procedures to ensure that formal advertised bids are solicited for purchases over \$50,000.

BP 3312, Contracts: The Superintendent or designee may enter into contracts and memoranda of agreement on behalf of the district. All contracts and memorandums of agreement with a dollar value of \$10,000 or greater must be approved by the School Board.

Issue Summary:

VIVA is the Visual Iñupiaq Vocabulary Assessment computer program that we use as a supplemental tool in our Iñupiaq Language classrooms and programs. Over the last year, we have been working with Nannut Qaqisaurajat, LLC, to work on the full upgrades of the VIVA computer program and have progressed through several of the foundational phases to relaunch the VIVA app as IVALU. In order for us to continue progressing forward and have a comprehensive assessment tool for our language progression as well as a way in which students can continue to practice their language progression, upgrades continue to be necessary.

We are now at a point where IVALU is ready to launch and can be downloaded on all district devices for students to use in all grade levels, not only in our Iñupiaq language classrooms but the general education classrooms as well. Although the IVALU app is available, there is still work that needs to be completed in the next phases of work which include: the IVALU release, completion of the student Leaderboard Section that will allow students to see a live leaderboard in real time across the district, the IVALU challenge which will allow students to have an added layer of practice on vocabulary and phrases they have already mastered, and rewriting the Login, Homepage, Lessons 1-8 pages, and the

Aarigaa Page so that it can be in website form which is the platform that is accessible to the public for parents, families, community, and partners to continue to have access.

The original VIVA website was built over 25 years ago using software that is now obsolete. When the original contract was proposed and entered into the company anticipated utilizing some assets and elements of the original website and code. However, as the overhaul has proceeded it has become apparent that the entire old site needs to be re-written to be usable on current platforms and also to be upgradeable and expanded by the Department in future. This addendum is necessary in this contract year to complete additional work on the new functionality of the IVALU website. Once this work is finalized there is one final stage of work to be completed prior to August 2024 to prepare the IVLAU site for launch in the new school year. A contract for that final launch completion work will be presented to the Board in May or June 2024.

Background:

Viva was started in 2007 and rolled out for student and teacher use in January 2009. The computer programming team we have been working with at Nannut Qaqisaurajat, LLC collectively have over 50 years of experience in computer programming and technical skills and training. This continued work would allow us to ensure that current components in the old VIVA app will be usable in IVALU.

Length of Contract:

The length of the contract would be an addendum to the current contract through June 30, 2024.

Funding Source and Purchase/Contract Amount:

This contract would be paid out of the Iñupiaq Education Department Professional & Technical budget Account Code: 100.200.120.000.410, in an additional amount of \$102,527.00.

Original contract approval: \$125,000.

Available Budget:

Compliance with BP 3311:

The administration requests that the requirements of BP3311 be waived in this instance.

The upgrading and modification of computer programming is a very specialized skill. The Iñupiaq Education Department initially spent 6 months searching for a computer programming company. During the search for a suitable company to perform the first phases of upgrades, updates and overhauling of VIVA, the department looked at several different companies, including the original developer, used a search program to solicit companies who offer computer programming, and other companies overseas. Nannut Qaqisaurajat, LLC. demonstrated at that time they had the expertise and necessary understanding of our requirements.
