Subject: Consider Approval of Renewal of Contract 2021.408 with Lincoln Financial for Life Insurance and Madison National Life (Ochs) for Disability Insurance for District Employees				
Background:  On June 28, 2021, the Board of Trustees awarded Contract 2021.408 to Lincoln Financial for life insurance and Madison National Life (Ochs) for long-term and short-term disability insurance. Lincoln Financial offers a range of products encompassing Basic Life, Basic Dependent Life, Accidental Death and Dismemberment (AD&D), Optional Employee Life, Optional Dependent Life, and Optional Employee AD&D. TRS-eligible district employees are entitled to \$25,000 in Basic Term Life Insurance and Long-Term Disability at no cost. Additional products from these carriers are available to employees at their own expense. The total contract value stands at \$1,590,000, with \$490,000 in CCISD premiums and \$1,100,000 in employee premiums. Lincoln has committed to maintaining our current rate for an additional year, extending until the contract's expiration on August 31, 2026. Madison has agreed to extend current rates for one more year, extending until the contract concludes on August 31, 2026.
