

Memorandum of Understanding (MOU)

For Emergency Support Services

Purpose

This MOU sets forth the terms of cooperation between KVH and Goldendale School District to support the hospital with goods or services during **declared emergency situations**, including but not limited to natural disasters, public health crises, or critical supply shortages.

Scope of Support

The vendor agrees to provide the following goods/services **during emergency events upon request** from KVH as long as it does not interfere with any school related activities and that actual costs will be reimbursed:

Description of goods/services:

- Transportation Needs
- Space as needed for patients/services
- Use of Kitchen

Services may include expedited delivery, priority access to stock, technical support, or deployment of personnel or equipment.

Activation of MOU

This MOU will only be activated upon a formal request by KVH or its designee. Such a request may be made via email, phone, or written communication and will specify:

- The nature of the emergency
- Requested goods or services
- Expected delivery or response time

Duration and Review

- The MOU may be reviewed and updated annually or as needed
- Either party may terminate the MOU with reasonable notice, unless active during an emergency response

Vendor Responsibilities

- Respond promptly to emergency activation requests
- Make reasonable efforts to prioritize hospital needs
- Notify the hospital immediately if unable to fulfill a request
- Maintain proper documentation for any emergency deliveries

Hospital Responsibilities

- Identify and communicate emergencies clearly
- Coordinate logistics for delivery or service setup
- Provide necessary access or credentials to hospital areas if required
- Compensate the vendor per agreed terms

Compensation

- Compensation will be determined **per emergency** and mutually agreed upon
- Pricing should reflect pre-established rate sheets or time/materials as applicable

Confidentiality and Compliance

Both parties agree to maintain the confidentiality of patient, operational, or proprietary information, and comply with HIPAA and all applicable laws during any engagement under this MOU.

Non-Binding Agreement

This MOU expresses good-faith intent and is not legally binding unless incorporated into a formal emergency procurement contract. However, both parties commit to working collaboratively in times of need.
