A brief discussion was held on Board Self Evaluations slated for August 14, 2021 this discussion by stating he isn't a doctor or and epidemiologist or health care professional. If we have to have something in place it will fall on the guidelines we had before COVID-19 or farm out to a 3rd party platform using ESSR funds. Follow CDC guidelines but we will not make masks mandatory and also that a Special Board meeting may be necessary as more information comes to light.
