3. <u>Reports & Presentations</u>

- Hiring Update: The district has hired approximately 30 new teachers and has 3 openings to fill.
- Administrative Staff: The 2015/16 administrative team was introduced.
- **CARE Update:** Peggy Doherty will be returning and interviews are taking place to replace Michele Misener.
- **Counseling:** Community Counseling Solutions will have a counselor in each community this year.
- **SRO:** An SRO has been hired through the City of Boardman. This position will also be teaching driver's education. The county is looking at hiring an SRO that will work in Irrigon and Heppner schools.
- **OEIB:** This has dissolved. There is a new position of Chief Education Office with Nancy Golden in the position.
- Smarter Balanced: There is an Opt Out bill regarding Smarter Balanced. This information will be sent out to parents two times a year.
- Funding: Educational funding is on solid ground in Oregon.
- **OSAA:** Concussions are a focus for OSAA. Next year there will be additional training required for football coaches -Heads-up Football and Impact training. Impact Training requires testing each athlete for a baseline. If an athlete is injured, they will be tested again to see if there is a concussion and what steps should be taken related to recovery and release back to participation.
- **Eastern Promise:** We continue to work with BMCC. Credits are going up this year to \$31/credit. We will continue to pay for credits using Education Foundation funds.
