# **Bid Opening**

Superintendent James Hess indicated the bid opening for the Gene Dillon Elementary School was held on December 8, 2016 with several companies submitting bids. Kraus-Anderson is currently qualifying bidders for the School Board to consider and approve.

### **City Council Meeting Update**

Ann Long Voelkner, Jeff Haack, and Chris Leinen attended a special work session of the City Council on November 28, 2016 and discussed: utility extension costs/interests, annexation timeline and desired areas, and the level of involvement by the Joint Planning Board. The City Council passed motions to extend City water and sewer to Adams Ave, and to develop a municipal services agreement with the School District including input from the Joint Planning Board staff.

### **Construction Budget**

Superintendent James Hess indicated the current new school budget revisions will occur as bid estimates come in. The Board will be asked to adopt an official budget at that time.

# **Property Purchase**

We purchased the Tarutis property last week as the site for the new Gene Dillon Elementary School.

### **Potential Reduction in Programs and Positions**

Carol L. Johnson introduced the following resolution and moved its adoption:

# RESOLUTION DIRECTING THE ADMINISTRATION TO MAKE RECOMMENDATIONS FOR REDUCTIONS IN PROGRAMS AND POSITIONS AND REASONS THEREFORE

WHEREAS, the financial condition of the school district may dictate that the School Board must consider a possible reduction in expenditures, and

WHEREAS, shifts in elementary and secondary student participation might cause discontinuance of positions and/or curtailment of programs, and

WHEREAS, a determination must be made concerning which teachers' contracts must be terminated and not renewed, and which teachers may be placed on unrequested leave of absence without pay or fringe benefits;

BE IT RESOLVED, by the School Board of Independent School District No. 31: That the School Board hereby directs the Superintendent of Schools and administration to consider the discontinuance of programs or positions to effectuate economies in the school district and reduce expenditures; and make recommendations to the School Board for discontinuance of programs, curtailment of programs, discontinuance of positions or curtailment of positions.

The motion for the adoption of the foregoing resolution was duly seconded by Ann Long Voelkner, and a tabulation of votes is as follows:
