Resolution Approving Independent Sources of Instruction Relating to Investment Responsibilities

Whereas, Section 2256.008, Texas Government Code, as amended, requires the treasurer, chief financial officer if the treasurer is not the chief financial officer, and the investment officer of a local government to attend an investment training session from an independent source approved by the governing body of the local government or a designated investment committee, within 12 months after taking office or assuming duties and not less than once in a two-year period thereafter:

("TASB"), First Public, LLC ("First Public"), the Texas Association of School Administrators ("TASA"), and the Texas Association of School Business Officials ("TASBO") provide investment training sessions relating to investment responsibilities under Section 2256.008; and
