Presentations/ Recognitions

The Denton Independent School District recently had three campuses named as recipients of the CREST Award, which annually recognizes the top counseling staffs in the state, by the Texas School Counselor Association. The campuses receiving awards are McNair Elementary, Harpool Middle School and Ryan High School. CREST stands for Counselors Reinforcing Excellence for Students in Texas and is a program that focuses on 10 areas that leave the greatest impact school counselors have on the achievements, career aspirations, personal gains and social aspects of students' lives.

Educator Spotlight features Kiaran Beck, music teacher at Borman Elementary an International Baccalaureate School. To bring the perspective of different cultures to her students, Ms. Beck uses Skype and an interactive white board to connect her students with friends from other countries. By enlisting music teachers in other countries to teach her students songs and customs, she brings relevance to her classroom. Students are becoming adept at using technology in a non-traditional setting.

The National Merit program annually recognizes students that are at-least one-quarter Hispanic or Latino and are among the top 5,000 high scoring individuals on the PSAT/NMSQT exam as National Hispanic Scholars. This year, two students from Guyer High were honored with this prestigious award. They include Carina Peltier and Anthony Rodriguez.

Innovation Zone

– Maker Space

Dwight Goodwin, Director of Instructional Technology showcased a sample of student learning through the innovative movement of Makerspace. Makerspaces provide students with space and time to pursue their unique passions. Enhance student problem solving skills through open-ended play and creation. Create a culture of success through failure, rather than one of success instead of failure and encourage student creativity by providing varied materials with which to build, tinker and make. Makerspaces have been created through joint funding between the Library department and individual school budgets.

Discussion of T-Tess & T-Pess Appraisal System Gwen Perkins, Human Resource Director provided the Board with an overview of the Texas Teacher Evaluation and Support System (T-TESS) and was created for teachers by teachers. This evaluation process promotes professional growth and targeted feedback which results in an improvement in practice.

Discussion of District Innovation Dr. Jamie Wilson, Superintendent explained that in the 2015 session, the Texas Legislature amended the Education Code to empower traditional school districts to enjoy some of the same flexibility that charter schools have. A District of Innovation can be exempt from certain requirements imposed by state law. These include: uniform start date; minimum minutes of instruction; the 90% rule; teacher contracts, benefits, and appraisals; campus decision making restrictions; certain budgeting requirements; and some student discipline laws. The Texas Education Agency (TEA) has not yet proposed rules for implementing this new

legislative scheme, but expects to do so soon. There are some basic steps a district has to follow:

First, a district's most recent academic performance rating must be at least "acceptable." Districts with a rating lower than that may not be designated as Districts of Innovation.

Second, just as with charters, there are certain laws that will still apply to a District of Innovation and from which there can be no exemption. These include: curricular and graduation requirements; accountability measures, including student assessments and financial reporting; public records and open meetings laws; some purchasing and contracting requirements; and all laws applicable to charter schools. Additionally, Districts of Innovation must provide prekindergarten, special education, and bilingual education to eligible students.

Third, designation as a District of Innovation may not exceed five years, though that designation can be amended, renewed, or rescinded through specific processes. TEA can also terminate the designation if the district's academic performance or financial accountability ratings are unacceptable.

Third Cycle Attendance Report Darrell Muncy, Director of Student Support Services provided the Board with the attendance percentages for each grade level for the third grading cycle (November 9, 2015 – December 18, 2015). The total attendance average for the Denton ISD for Cycle 3 is 95.46%. The lowest total attendance average is for PK (90.84), followed by 12th grade (93.94). The highest attendance averages are in the 5th grade (96.12), followed by 6th grade (96.02). First Semester attendance for 78 days of instruction is 96.34%
